Treatment of Preconstruction Lumber and Logs

General Information: TIMBERTREAT® 4 WT insecticide can be diluted with water or suitable base oil. To prepare the mixture, dilute TIMBERTREAT® 4 WT as shown in the following Dilution Chart.

Directions for Application

To protect unseasoned or seasoned lumber and logs from wood destroying insects, such as termites, carpenter ants and beetles (ambrosia, powder-post, old house borers and others), treat the wood with up to a 1.0% dilution of chlorpyrifos. This dilution can be applied by spraying, brushing, dipping or pressure treatment. Monitoring of the treating mixture may be necessary to insure that the desired level of chlorpyrifos is maintained. Wear protective clothing and chemically resistant gloves during treatment and when handling freshly treated wet wood. Wood can be safely handled after treatment when dry.

- Dip Treatment. Rates of 0.5% to 1.0% are recommended for dip treatments to insure adequate retentions. The wood should be totally submerged in the dilution until thoroughly wet and then allowed to dry in a suitable location. Dipping solutions to which TIMBERTREAT* 4 WT has been added should be agitated before use if left unused for a period of time.
- Pressure Treatment. Rates of 0.25% to 0.5% are recommended for adequate penetration and retention. After the pressure is released and the system drained, the wood should be placed in a suitable location for drying.
- Spray Treatment and Brush Treatments. Rates of 0.5% to 1.0% are recommended for spray and brush treatments. The wood should be sprayed or brushed thoroughly, including back and ends, with the treating mixture.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

Storage; Store in original container in secured dry storage area. Prevent cross-contamination with other pesticides and fertilizers. Do not store above 100°F for extended periods of time. Storage below 20°F may result in formation of crystals. If product crystallizes, store at 50 to 70°F and agitate to redissolve crystals. If container is damaged or spill occurs, use product immediately or dispose of product and damaged container as indicated below.

Pesticide Disposal: Pesticide wastes are toxic. Improper disposal of excess pesticide, spray mixture, or rinsate is a violation of Federal Law.
