



Product Description: This Product is an ablative antifouling coating designed to polish away at a controlled rate, constant-ly exposing a fresh surface which provides excellent season-long antifouling protection. The high loading of cuprous oxide, in the formula enables the paint to perform well in even the most severe fouling areas. The controlled erosion minimizes coating buildup and keeps underwater surfaces smooth and clean. This product may be applied on fiberglass, wood and properly primed steel boats

properly primed steet loads.

Compatibility: This product may be applied over most aged hard antifouling coatings and over most copper-based ablative antifouling coatings. Old soft antifouling paints must be completely removed before applying this product.

Mixing: This product is heavily loaded with cuprous oxide. As a result of this loading, there is a tendency for settling to occur especially if the paint has been on the shelf for several months. It is necessary to thoroughly mix the paint before using. If possible shake the can of paint on a mechanical paint shaker. Before using check the sides and bottom of the can to make sure all the pigment has been mixed in. If mixing is going to be done with a wooden paddle or an electric drill mixer, pour off half of the liquid from the top of the can into another can and then properly mix in any settled pigment, then remix the two parts together thoroughly.

Application Temperatures: 50°F and above

Application Method: Brush, roller or spray.

Thinner: Thinning this product is not normally required. If thinning is necessary, use Pettit 120/7-10 Brushing Thinner only. Do not thin more than 10% by volume (12 ounces per gallon) or inadequate paint film thickness may result in premature erosion of the finish.

Coverage: This product covers approximately, 500 square feet per gallon.

Number of Coats: For best antifouling protection at least two full coats of this product are recommended for the first years, protection. It is a good idea for the first coat to be painted in a different color from the top coats. As the topcoat wears away, the base color will start to show through, signaling that it will soon be time to haul and repaint.

Man-made pollution and natural occurrences can adversely affect antifolding paint performance. Extreme hot and cold temperatures, silt, dirt, oil, brackish water and even electrolysis can ruin an antifolding paint. Therefore we strongly suggest that the bottom of the boat be checked regularly to make sure it is clean and that no growth is occurring. Lightly scrub-the bottom with a soft brush to remove anything from the antifouling paint surface. Scrubbing is particularly important with boats that are idle for extended periods of time. The self-cleaning nature of the coating is most effective when the boat is used periodi-

The paint systems outlined below contain references to other Petiti products. Previously Painted Surfaces: If the previous coating is in good condition, thoroughly sand with 80 grit production paper and wipe clean with a rag dampened with Petit 120/T-10/Brushing Thinner to remove sanding residue. Apply two coats of this product observing the proper dry times. If the previous coating is soft or in poor condition, remove to the bare surface by sanding or using paint and varnish remover. Proceed with appropriate bare system as described below. Old tin copolymer paints must be removed before applying this product.

Bare Fiberglass: All bare fiberglass, regardless of age, must be thoroughly cleaned using Pettit 95 Fiberglass Dewaxer and

clean lint-free rags. Several cleanings may be necessary to ensure complete removal of contaminants. Change rags frequently during the dewaxing/cleaning process to ensure complete removal of contaminants rather than merely smearing. them on the surface. New boats must be scrubbed with a detergent and water solution and rinsed with fresh water prior to dewaxing. After the surface has been dewaxed, sand it thoroughly with 80 grit production paper and rewash the sanded surfaces with Petit 95 Dewaxer or 120/T-10 Brushing Thinner to remove sanding residue. Apply two coats of this product observing the proper dry times. If sanding is prohibited, as with certain vinyl-ester gelcoats, or is otherwise impractical, make sure the surface has been completely and thoroughly dewaxed and cleaned with Pettit 95 Fiberglass Dewaxer. Then apply one thin continuous coat of Pettit 6999 Sandless Primer. Topcoat with two coats of this product carefully following the toncoating instructions on the Sandless Primer label-

Bare Wood: Sand entire surface with 80 grit production paper and wipe clean with a rag dampened with 120/T-10 Brushing Thinner. Apply a coat of Petiti 6627 Tie Coat Primer thinned 10% to penetrate and seal the wood. Fill any open seams with Petiti Seam Compound and allow to dry overnight. Apply two full coats of this product observing the proper dry times.

Saars Steet: Sandblast to clean, bright metal and remove blasting residue with clean, dry compressed air or a clean brush; Immediately apply two coats of Petiti 4700/4701. Petiti Protect Epoxy Primer. Read and follow carefully the instructions on the 4700/4701 Petiti Protect Epoxy Primer albel. If the surface to be painted will be prepared using had tools such as wire wheels or sanders, clean off residue and immediately apply one coat of Petiti 6980 Rustlok Steel Primer. Let dry 1-2 hours, and follow with two coats of Petiti 4700/4701. Petiti Protect Epoxy Primer. Read and follow carefully the instructions for application and topcoating on both primer labels.
