ValvTect Marine Premium Diesel Additive with BioGuard Microbiocide is a highly effective multifunctional premium diesel fuel additive containing BioGuard Microbiocide to prevent bacterial growth in diesel fuel (No. 2 oil, intermediate fuel oil and No.6 oil). Add ValvTect Marine Premium Diesel Additive with BioGuard Microbiocide to storage tanks at a rate of one gallon to 1500 Gallons (667ppm) or one quart to 375 gallons of diesel fuel.

DOSAGE RATE

Treatment may be performed by slug dosage or intermittent metering. To facilitate mixing by slug dosage, add ValvTect Marine Premium Diesel Additive with BioGuard Microbiocide to the fuel transport or storage tank prior to adding fuel. Storage tank should have a 20% heel of fuel and be free of excess water and/or sludge.
