The Agency is in receipt of your Application for Pesticide Notification under Pesticide Registration Notice (PRN) 98-10 for the above referenced product. The Antimicrobials Division (AD) has conducted a review of this request for its applicability under PRN 98-10 and finds that the action requested falls within the scope of PRN 98-10.

The alternate brand name, West Marine Bottomshield Antifouling Paint, has been added to the product record.

The label submitted with the application has been stamped “Notification” and will be placed in our records.

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Product Description: This product's durable hybrid surface resists paint buildup by slowly polishing which constantly exposes a fresh surface for economical antifouling protection. The controlled erosion minimizes coating buildup and keeps underwater surfaces smooth and clean. This product cleans up with soap and water and may be applied on all boat substrates except aluminum. This product is for use in fresh, salt or brackish water on hulls below the waterline and is resistant to barnacles, algae and other fouling organisms. This paint is intended for use on recreational and commercial vessels of any size.

Surface Preparation: The surface to be painted should be dry, clean and free of any contaminants. It should be properly prepared by solvent cleaning and sanding before any primers or paints are applied. Follow the recommended systems below. When sanding old antifouling paint, always wear Personal Protective Equipment (PPE) as described above to prevent the inhalation of sanding dust.

Coverage, Application and temperature: This product can be applied by brush, short nap roller or spray. All painting should be done between 9:00 a.m. and 4:00 p.m. in order to avoid the possibility of dew or condensation spoiling the application. The temperature range of application should be between 50 and 90°F. At least two, and preferably three coats, should be applied for best performance, particularly in high wear areas such as the waterline. This product will cover approximately 500 square feet per gallon when applied at 2 dry mils film thickness.

Preparation of Paint: This product contains cuprous oxide. As a result, there is a tendency for settling to occur especially if the paint has been on the shelf for several months. It is necessary to thoroughly mix the paint before using. A mechanical paint shaker will do the fastest most thorough job of mixing. If mixing is to be done with a wooden paddle or electric drill mixer, pour off half of the liquid from the top of the can into another can and then properly mix in any settled pigment, then remix the two parts together thoroughly. Regardless of the mixing method, check the sides and bottom of the can before and during use to make sure all contents are thoroughly mixed.

Thinner/ Clean-Up: Use 140 Water-Based Brushing Thinner. Thinning this product is not normally required. Do not thin more than 10% by volume (12 ounces per gallon).

Number of Coats: Two or three coats should be applied for best antifouling protection. Do not apply this product if rain or dew is expected before the surface has dried completely.

Dry Times:	To recoat	To launch
90°F	1 ½ hours	6 hours
70°F	3 hours	10 hours
50°F	6 hours	16 hours

The above dry times are minimums. This product may be recoated and launched after the minimum times shown. Dry times will vary with environmental conditions. If unsure of the dry time, it is safer to launch later rather than earlier. There is no maximum dry time before launching.

VOC: 145 grams/liter (1.25 lbs./gal) maximum.

Maintenance Of Antifouling Paint: No antifouling paint can be effective under all conditions of exposure. Man-made pollution and natural occurrences can adversely affect antifouling paint performance. Extreme hot and cold water temperatures, silt, dirt, oil, brackish water and even electrolysis can ruin an antifouling paint.

Therefore, we strongly suggest that the bottom of the boat be checked regularly to make sure it is clean and that no growth is occurring. The self-cleaning nature of the coating is most effective when the boat is used periodically. Boats and vessels should not be scrubbed or cleaned for the first six months in the water and at intervals of not less than 3 months thereafter.

STORAGE & DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. Open dumping is prohibited.

Pesticide Storage: Store in a closed, properly labeled container in a cool place. Keep closures tight and upright to prevent leakage. Keep container closed when not in use. In case of spillage, absorb and dispose of in accordance with local applicable regulations.

Pesticide Disposal: Pesticide wastes are toxic. Improper disposal of excess pesticide, spray mixture or rinsate is a violation of Federal law. If these wastes cannot be disposed of by use according to label instructions, contact your State Pesticide or Environmental Control Agency, or the Hazardous Waste Representative at the nearest EPA Regional Office for guidance.

Container Disposal: Non-refillable container. Do not reuse or refill this container. Prior to container disposal, Allow any remaining paint residue in the container to air dry. Dispose of the container in accordance with Federal, State or local disposal regulations.

SYSTEMS

Mix paint thoroughly to ensure contents are evenly dispersed throughout the can. All surfaces must be clean, dry and properly prepared prior to painting.

Previously Painted Surfaces: If the previous coating is in good condition thoroughly sand with 80 grit paper and wipe clean with a rag dampened with Pettit 120 Brushing Thinner or 140 Water-Based Brushing Thinner to remove sanding residue. Apply two coats of this product observing the proper dry times , If the previous coating is soft or in poor condition, remove to the bare surface by sanding or using paint and varnish remover . Proceed with the appropriate bare system as described below.

Bare Fiberglass: All bare fiberglass, regardless of age, must be thoroughly cleaned and de-waxed with Pettit 92 Bio-Blue Hull Surface Prep or de-waxed several times with Pettit D95 Dewaxer. Sand thoroughly with 80 grit sandpaper to a dull, frosty finish and rewash the sanded surface with 120 Brushing Thinner or 140 Water-Based Brushing Thinner to remove sanding residue. Then apply two coats of this product, following application instructions, To eliminate the sanding operation, two methods are available:

1. Clean and de-wax the surface as described above, apply one very thin coat of 6998W Skip-Sand Primer using 3/16" or less nap roller or brush apply. Consult the primer label for complete application and antifouling top-coating instructions. Then apply two coats of this product or
2. Clean, de-wax and etch the surface with 92 Bio-Blue Hull Surface Prep using a coarse Scotchbrite® pad. Clean off all residue by rinsing or wiping off with fresh water. Apply one coat of Pettit Protect Epoxy Primer 4700/4701 or H2Prime 4740/4741. Consult the primer labels for complete application and antifouling top-coating instructions. Then apply two coats of this product.

Bare Wood: Sand the entire surface with 80 grit production paper and wipe clean with a rag dampened with 120 Brushing Thinner. A primer coat of Pettit 6627 Tie Coat Primer should be applied directly to bare wood. Allow to dry 4 hours, then apply two un-thinned coats of this product per instructions

Steel Hulls, Underwater Metal Parts and Keels: For steel hulls and metal keels, consult Pettit Technical Bulletin TB43I High Build Epoxy Primer for complete priming instructions or consult the Pettit Technical Department or your local Pettit representative for underwater metal parts, consult Technical Bulletin TB112 Underwater Running Gear Painting Specification for complete priming and application details

Rubberized Fabric Surfaces: Scrub the rubberized fabric surfaces with a bronze wool pad dipped in Pettit 97 Epoxy Thinner. Choose a small area on the surface to be painted and scrub the surface lightly but thoroughly, making sure the surface is completely wetted by the 97 Epoxy Thinner. Once all the fabric has been treated with the 97 Epoxy Thinner wipe up all residue and allow the fabric to dry for one hour. Once the surface has been properly prepared, apply a generous coat of this product. Allow the paint to dry to recoat and apply a full second coat. Consult the dry to recoat/dry to launch time-temperature chart above for specific recoat and launch times.

NOTE: All antifouling paints may leave a stain if left in contact with other objects. When the boat is pulled out of the water for storage on deck or on a dock, clothing, deck and dock surfaces coming in contact with the antifouling paint may experience staining if rubbed against the antifouling paint.
