The Agency, in accordance with the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, has completed reviewing all of the information submitted with your application to support the Registration Review of the above referenced product in connection with the Prodiamine Interim Decision, and has concluded that your submission is acceptable. The agency also completed review of your amended label referred to above, submitted in connection with registration under FIFRA, as amended, and has determined the label is also acceptable.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide Fungicide and Rodenticide Act and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Compliance.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. You must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. Products shipped after 18 months from the date of this amendment must bear the new revised label. Your release for shipment of the product bearing the amended label constitutes acceptance of these conditions. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6.

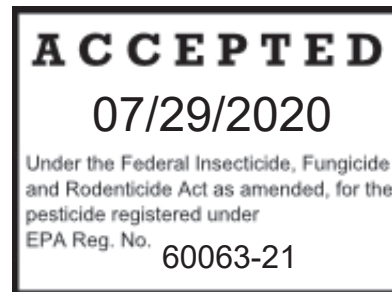

- Christmas tree farms;
- Managed transportation and utility rights-of-way, including rail and equipment yards, and public utility facilities (substations, tank farms, pumping stations, parking/storage areas, ungrazed fencerows).

This product is a technical active ingredient intended to be used only in the manufacture of registered noncrop end-use products. Each formulator is responsible for obtaining the EPA registration of his formulated product(s).

## STORAGE AND DISPOSAL
