On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act. - 1. Revise text under product name to read: "A Rodenticide only for Formulation into Registered Products".
- 2. In your Ingredient Statement, remove the "S" from "ACTIVE INGREDIENTS".
- 3. Revise your text under "DANGER" to read:

Fatal if swallowed, absorbed through the skin or inhaled. Causes moderate eye irritation. Do not breathe dust. Do not get in eyes, on skin, or on clothing. Wash hands before eating eating, drinking, chewing gum, using tobacco or using the toilet. Remove contaminated clothing and wash clothing before reuse. Wash thoroughly with soap and water after handling. Avoid exposure to this product during pregnancy.

The PPE text, "When mixing baits, wear dust respirator and rubber gloves." is optional.

4. Revise your use directions as follows:

#### **DIRECTIONS FOR USE**
