Do not use in edible product areas of food or feed processing plants or other areas where food or feed is commercially prepared or processed. Do not contaminate food/feed or food/feed handling equipment or place near or inside ventilation duct openings. Do not broadcast bait. NORWAY AND ROOF RATS: Apply 2-8 bait packs per bait placement. Space placements at intervals of 15 to 30 feet in infested areas. Maintain an uninterrupted supply of fresh bait for at least 10 days or until there no longer are signs of new feeding by rats.

HOUSE MICE: Open bait pack and apply ¼ to ½ ounces (1-2 level tablespoons) of bait at each placement location. Space placements at 8- to 12-foot intervals. Larger placements (up to 2 ounces) may be needed at points of very high house mouse activity. Maintain an uninterrupted supply of fresh bait for at least 15 days or until there are no longer signs of new feeding by house mice.

FOLLOW-UP: Replace contaminated or spoiled bait immediately. Using waterproof gloves collect and dispose of all dead, exposed animals and leftover bait properly. To discourage reinfestation, limit sources of rodent food, water and harborage as much as possible. If reinfestation does occur, repeat treatment. Where a continuous source of infestation is present, establish permanent bait stations and replenish as needed.
