

#### DIRECTIONS FOR USE:

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

**IMPORTANT:** Do not expose children, pets, or other nontarget animals to rodenticides. To help to prevent accidents:

1. Store product not in use in a location out of reach of children and pets.
2. Apply bait in locations out of reach of children, pets, domestic animals and nontarget wildlife, or in tamper-resistant bait stations. These stations must be resistant to destruction by dogs and by children under six years of age, and must be used in a manner that prevents such children from reaching into bait compartments and obtaining bait. If bait can be shaken from stations when they are lifted, units must be secured or otherwise immobilized. **RATS:** Apply 4 to 16 ounces of bait per placement. Maintain an uninterrupted supply of fresh bait for at least 10 days.

**MICE:** Apply ¼ to ½ ounce of bait at 8- to 12-foot intervals. Larger placements (up to 2 ounces) may be needed at points of very high mouse activity. Maintain an uninterrupted supply of fresh bait for at least 15 days.

This 16-ounce bar may be broken or cut into five 3-1/5-ounce bars for rats. The 3-1/5-ounce bars may be broken or cut into six ¼-ounce or twelve 1/8-ounce bars for mice.

**RATS/MICE:** Replace contaminated or spoiled bait immediately. Collect and dispose of all dead animals and leftover bait properly. To prevent reinfestation, limit sources of rodent food, water, and harborage as much as possible. If reinfestation does occur, repeat treatment. Where a continuous source of infestation is present, establish permanent bait stations and replenish as needed.

### STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.
