The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. You must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide Fungicide and Rodenticide Act and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Compliance.

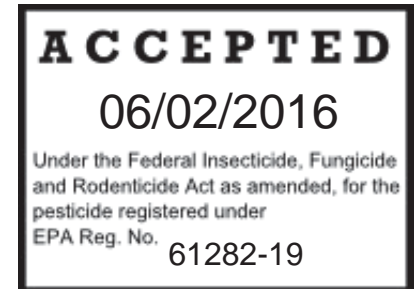

**IMPORTANT:** Do not expose children, pets or other non-target animals to rodenticides. To help to prevent accidents:

1. Store product not in use in a location out of reach of children and pets.
2. Apply bait in locations out of reach of children, pets, domestic animals and non-target wildlife.
3. Dispose of product container, and unused, spoiled, and unconsumed bait as specified on this label.

### **USE RESTRICTIONS:**

**DO NOT USE THIS PRODUCT OUTDOORS OR IN AREAS ACCESSIBLE TO CHILDREN, PETS, DOMESTIC ANIMALS, OR NON-TARGET WILDLIFE.**

This product may only be used to control the following rodent pests in man-made structures: House mouse (*Mus musculus*), Eastern harvest mouse (*Reithrodontomys humuli*), Golden mouse (*Ochrotomys nuttalli*), and Meadow vole (*Microtus pennsylvanicus*). Examples of such structures include homes and other permanent or temporary residences, food processing facilities, industrial and commercial buildings, agricultural and public buildings, transport vehicles, (ships, trains, aircraft), port or terminal buildings and related structures around and associated with these sites.

**SELECTION OF TREATMENT AREAS:** Determine areas where house mice will most likely find and consume the bait. Generally, these areas are along walls, by gnawed openings, in corners and concealed places, between floors and walls, or in locations where rodents or their signs have been seen. Remove as much alternative food as possible.

### **APPLICATION DIRECTIONS:**

**MICE AND MEADOW VOLES:** Place a single unit at each placement location. Space placements at 8 to 12 foot internals. Replace units if contents are consumed or contaminated, or if units are severely damage. If units are untouched after three days, move to new locations consistent with label text. Maintain an uninterrupted supply of fresh bait for at least 15 days or until there are no longer signs of new feeding by mice or meadow voles.

**FOLLOW-UP:** Replace contaminated or spoiled bait immediately. Using barrier laminate gloves collect and dispose of all dead, exposed animals and leftover bait properly. To discourage reinfestation, limit sources of rodent food, water and harborage as much as possible. If reinfestation does occur, repeat treatment.

### **STORAGE AND DISPOSAL**

**PESTICIDE STORAGE:** Store only in original container in a dry place inaccessible to children and pets.

**PESTICIDE DISPOSAL AND CONTAINER HANDLING:** Nonrefillable container. Do not reuse or refill this container.

*If partly filled:* Call your local solid waste agency for disposal instructions. Never place unused product down any indoor or outdoor drain, place in trash or offer for recycling if available.
