HOUSE MICE: Open package and apply ¼ to ½ ounces (1-2 level tablespoons) of bait at each placement location. Space placements at 8- to 12-foot intervals. Larger placements (up to 2 ounces) may be needed at points of very high house mouse activity. Maintain an uninterrupted supply of fresh bait for at least 15 days or until there are no longer signs of new feeding by house mice.

**FOLLOW-UP:** Replace contaminated or spoiled bait immediately. Using waterproof gloves collect and dispose of all dead, exposed animals and leftover bait properly.
