- 1. On the front panel on both the outer and inner labels, change "Rodents may consume a lethal dose in one feeding with first dead rodents appearing four or five days after treatment begins." to "Norway rats and house mice may consume a lethal dose in one night's feeding with first dead rodents appearing four or five days after feeding begins."
- 2. Revise your "PRECAUTIONARY STATEMENTS" on the outer and inner labels as follows:

 PRECAUTIONARY STATEMENTS

Hazards to Humans and Domestic Animals

CAUTION: Harmful if swallowed. Harmful if absorbed through skin. Keep away from children, domestic animals, and pets. Avoid contact with skin. Do not get in eyes or on clothing. All handlers (including applicators) must wear shoes plus socks, and gloves. Any person who retrieves carcasses or unused bait following application of this product must wear waterproof gloves.

User Safety Requirements

Follow manufacturer's instruction for cleaning/maintaining PPE. If no such instructions for washables, use detergent and hot water. Keep and wash PPE separately from other laundry. Remove PPE immediately after handling this product. Wash the outside of gloves before removing. As soon as possible, wash hands thoroughly after applying bait and before eating, drinking, chewing gum, using tobacco or using the toilet and change into clean clothing.

Include the following First Aid statement directly beneath the "If swallowed" statement in the FIRST AID box:

If on skin or clothing	Take off contaminated clothing.

Beneath the FIRST AID box, include a separate NOTE TO PHYSICIAN and NOTE TO VETERINARIAN statements as follows:

NOTE TO PHYSICIAN

If swallowed, this material may reduce the clotting ability of the blood and cause bleeding. If ingested, administer Vitamin K_1 intramuscularly or orally. Vitamin K_1 is antidotal at doses of 10-20mg (not mg/kg). Repeat as necessary based on monitoring of prothrombin times.

TREATMENT FOR PET POISONING

If animal eats bait, call veterinarian or 1-800-498-5743 at once.

NOTE TO VETERINARIAN

Anticoagulant Brodifacoum: For animals ingesting bait and/or showing poisoning signs (bleeding or elevated prothrombin times), give Vitamin K₁ at doses of 2-5 mg/kg. If needed, check prothrombin times every 3 days until values return to normal (up to 30 days). In severe cases, blood transfusions may be needed.

Environmental Hazards

This product is extremely toxic to mammals and birds. Dogs and predatory and scavenging mammals and birds

might be poisoned if they feed upon animals that have eaten this bait. This pesticide is toxic to fish. Do not apply directly to water, or to areas where surface water is present or to intertidal areas below the mean high water mark. Runoff also may be hazardous to aquatic organisms in water adjacent to treated areas. Do not contaminate water when disposing of equipment wash water or rinsate.

- 3. In the "DIRECTIONS FOR USE" section on the inner and outer labels, add the following text after "Read this entire label...use precautions": "Use only for the sites, pests, and application methods described on this label."
- 4. At the end of "IMPORTANT" and immediately before "USE RESTRICTIONS" on the inner and outer labels, add: "Note: Bait stations are mandatory for outdoor, above-ground use. Tamper-resistant bait stations must be used if children, pests, non-target mammals, or birds may access the bait."
- 5. Make the following revisions to the USE RESTRICTIONS section on the inner and outer labels:
 - a. Revise the first sentence to read "For control only of house mice, Norway..."
 - b. Place the sentence beginning with "Do not apply further than..." after the first sentence.
 - c. Remove "This product may also be used ... or terminal buildings."
 - d. Add the following statement after the sentence ending in "...contact with food." "Do not use in edible product areas of food or feed processing plants or other areas where food or feed is commercially prepared or processed. Do not contaminate food/feed or food/feed handling equipment or place near or inside ventilation duct openings."
 - e. Move the sentence, "Do not apply further...agricultural buildings." immediately after the first sentence.
 - f. Add the statement "Do not use in homes or other human residences." after the sentence ending with "...8 pounds of bait."
- 6. Revise the first sentence of the SELECTION FOR TREATMENT AREAS on the inner and outer labels to read "Determine areas where house mice and/or rats..."
- 7. Make the following revisions to the APPLICATION DIRECTIONS section on the inner and out labels:
 - a. Add "Wearing gloves" to the first sentence so it reads "Wearing gloves, open pack and apply..."
 - b. Add "house" before mouse in the third sentence to read "...very high house mouse activity."
 - c. Add "house" before mouse in the last sentence to read "...signs of house mouse activity cease."
 - d. Revise the title "Mice and Rats" to read "Follow Up."
 - e. Revise the first two sentences to read "While wearing gloves, replace contaminated or spoiled bait immediately and collect and dispose of all dead rodents and left over bait properly."
 - f. Delete the last two sentences from this section as these belong in the USE RESTRICTIONS section and are already located there.
- 8. Use the following text to revise the STORAGE AND DISPOSAL on the inner and outer labels as stated in PR Notice 2007-4 text to include all types of containers used to hold your product:

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

Non-Household Label

Pesticide Storage: Store only in original container in a cool, dry place inaccessible to children and pets. Keep containers closed and away from other chemicals.

Pesticide Disposal: Wastes resulting from the use of this product, and spoiled and unconsumed bait, may be

disposed of on site or at an approved waste disposal facility. Never place unused product down any indoor or outdoor drain.

Container Handling: Non-refillable container. Do not reuse or refill this container. [Plastic:] Outer Bait Container: Triple rinse (or equivalent) then offer for recycling or reconditioning; or puncture and dispose of in a sanitary landfill; or incineration. [Paper] Bait Pack: Dispose of empty container by placing in trash, at an approved waste disposal facility or by incineration.

- 9. Include the statement "To the extent consistent with applicable law." to your warranty statement on the inner and outer labels.
- 10. As stated in 40CFR156,140(a)(4), a batch code must be included on the label or package for container and containment for nonrefillables.

The acceptable Confidential Statement of Formula (CSF) for this product is dated February 18, 2003. All other versions are obsolete.

Stocks of product with existing labels may be used until June 4, 2011. As stated under the Terms and Conditions of Sale and Distribution on page 35 of the Agency's revised May 28, 2008 "Risk Mitigation Decision for Ten Rodenticides":

- a. Product is prohibited for sale in stores oriented towards residential consumers: Grocery, Drug, Hardware and Home Improvement. It is acceptable for sale in stores oriented toward agricultural consumers: Farm, Agricultural, Tractor Stores.
- b. Product may not be sold in packaging that holds less than 8 pounds of bait.

This product is in full compliance with the Agency's revised May 28, 2008 "Risk Mitigation Decision for Ten Rodenticides".

IMPORTANT: Do not expose children, petr, or other nonterest animals to adapticides. To half

IMPORTANT: Do not expose children, pets, or other nontarget animals to rodenticides. To help to prevent accidents:

- 1. Store product not in use in a location out of reach of children and pets.
- 2. Apply bait in locations out of reach of children, pets, domestic animals and nontarget wildlife, or in tamper-resistant bait stations. These stations must be resistant to destruction by dogs and by children under six years of age, and must be used in a manner that prevents such children from reaching into bait compartments and obtaining bait. If bait can be shaken from stations when they are lifted, units must be secured or otherwise immobilized. Even stronger bait stations are needed in areas open to hoofed livestock, raccoons, bears, or other potentially destructive animals, or in areas prone to vandalism.

USE RESTRICTIONS: For control of house mice, Norway rats, and roof rats in and around agricultural buildings. This product may also be used in transport vehicles (ships, trains, aircraft) and in and around related port or terminal buildings. Do not use in sewers. Do not place bait in areas where there is a possibility of contaminating food or surfaces that come in direct contact with food. Do not broadcast bait. Do not apply further than 50 feet from agricultural buildings. Do not sell this product in individual containers holding less than 8 pounds of bait.

SELECTION OF TREATMENT AREAS: Determine areas where mice and/or rats will most likely find and consume the bait. Generally, these areas are along walls, by gnawed openings, in or beside burrows, in corners and concealed places between floors and walls, or in locations where rodents or their signs have been observed. Remove as much food as possible.

APPLICATION DIRECTIONS:

House Mice:

Open pack and apply ½ to ½ ounce of bait per placement location. Space placements at 8- to 12-foot intervals. Larger placements (up to 2 ounces) may be needed at points of very high mouse activity. Maintain an uninterrupted supply of fresh bait for 15 days or until signs of mouse activity cease.

Norway and Roof Rats:

Apply two to eight 1.76-oz bait packs per placement. Space placements at 15- to 30-foot intervals in infested area. Maintain an uninterrupted supply of fresh bait for 10 days or until signs of rat activity cease. Two place packs contain enough bait (100 g) to kill one to three rats.

Mice and Rats:

Replace contaminated or spoiled bait immediately. Collect and dispose of all dead rodents and left over bait properly. To prevent reinfestation, limit sources of rodent food, water, and harborage as much as possible. Where a continuous source of infestation is present, maintain permanent bait stations and replenish toxic bait as needed. Do not apply further than 50 feet from agricultural buildings. Do not sell this product in individual containers holding less than 8 pounds of bait.
