## APPLICATION DIRECTIONS

**NORWAY AND ROOF RATS:** Apply 2 to 8 1.76oz bait packs per placement. Space placements at intervals of 15 to 30 feet in infested areas. Maintain an uninterrupted supply of fresh bait for at least 10 days or until there no longer are signs of new feeding by rats. Two place packs contain enough bait (100g) to kill one to three rats.

**HOUSE MICE:** Open pack and apply  $\frac{1}{4}$  to  $\frac{1}{2}$  ounce of bait at each placement location. Space placements at 8- to 12-foot intervals. Larger placements (up to 2 ounces) may be needed at points of very high house mouse activity. Maintain an uninterrupted supply of fresh bait for at least 15 days or until there are no longer signs of new feeding by house mice.
