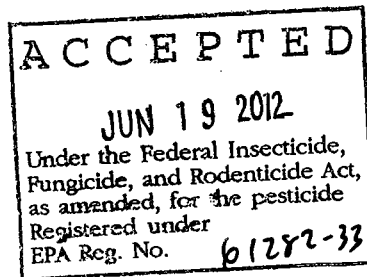

2. Apply bait in locations out of reach of children, pets, domestic animals and non-target wildlife, or in tamper-resistant bait stations. Examples of such structures include homes and other permanent or temporary residences, food processing facilities, industrial and commercial buildings, trash receptacles, agricultural and public buildings, transport vehicles (ships, trains, aircraft), docks and port of terminal buildings and related structures around and associated with these sites. Fence and perimeter bait, beyond 100 feet from any structure as defined above, is prohibited. This product must not be applied directly to food or feed crops.

Burrow baiting with Hopkins Rodex™ Pelleted Bait-1 is prohibited.

Do not place near or inside ventilation duct openings. HOUSE MICE: Apply ½ to ½ ounces of bait at each placement location. Space placements at 8- to 12-foot intervals. Larger placements (up to 2 ounces) may be needed at points of very high mouse activity. Maintain an uninterrupted supply of fresh bait for at least 15 days or until there no longer are signs of new feeding by house mice.

FOLLOW-UP: Replace contaminated or spoiled bait immediately. Using waterproof gloves collect and dispose of all dead, exposed animals and leftover bait properly. To discourage reinfestation, limit sources of rodent food, water and harborage as much as possible. If reinfestation does occur, repeat treatment. Where a continuous source of infestation is present, establish permanent bait stations and replenish as needed.
