The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. You must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide Fungicide and Rodenticide Act and is subject to review by the Agency. ENVIRONMENTAL HAZARDS

This product is extremely toxic to mammals, birds and other wildlife. Dogs, cats and scavenging mammals and birds might be poisoned if they feed upon animals that have eaten this bait. Do not apply directly to water, or to areas where surface water is present or to intertidal areas below the mean high water mark. Do not allow bait to be exposed on soil surface. Do not apply where runoff is likely to occur. Do not contaminate water when disposing of equipment wash water or rinsate.

DIRECTIONS FOR USE

This product may only be used to control the following rodent pests in and around man-made structures: House mouse (*Mus musculus*), Norway rat (*Rattus norvegicus*), Roof rat (*Rattus rattus*), Cotton rats (*Sigmodon hispidus*)*, Eastern harvest mouse (*Reithrodontomys humuli*)*, Golden mouse (*Ochrotomys nuttalli*)*, Polynesian rat (*Rattus exulans*)*, and Meadow vole (*Microtus pennsylvanicus*)*, White-throated woodrat (*Neotoma albigula*)*, Southern plains woodrat (*Neotoma micropus*)*, Mexican woodrat (*Neotoma mexicana*)*,. This product must be used in and within 100 feet of man-made structures constructed in a manner so as to be vulnerable to commensal rodent invasions and/or to harboring or attracting rodent infestations. Examples of such structures include homes and other permanent or temporary residences, food processing facilities, industrial and commercial buildings, trash receptacles, agricultural and public buildings, transport vehicles, (ships, trains, aircraft), docks and port or terminal buildings and related structures around and associated with these sites. Fence and perimeter baiting, beyond 100 feet from a structure as defined above, is prohibited. This product must not be applied directly to food or feed crops.

Burrow baiting with Ramik Green is prohibited.

Do not sell this product in individual containers holding less than four (4) pounds of bait. SELECTION OF TREATMENT AREAS: Determine areas where rats, mice or meadow voles will most likely find and consume the bait. Generally, these areas are along walls, by gnawed openings, in corners and concealed places, between floors and walls, or in locations where rodents or their signs have been seen. Protect bait from rain or snow. Remove as much alternative food as possible.

APPLICATION DIRECTIONS

RATS*: Place 4 to 16 ounces of bait per placement. Space placements at intervals of 15 to 30 feet in infested areas. Maintain an uninterrupted supply of fresh bait for at least 10 days or until there no longer are signs of new feeding by rats.

MICE AND MEADOW VOLES*: Open package and apply ¹/₄ to ¹/₂ ounces (1-2 level tablespoons) of bait at each placement location. Space placements at 8- to 12-foot intervals. Larger placements (up to 2 ounces) may be needed at points of very high mouse or meadow vole activity. Maintain an uninterrupted supply of fresh bait for at least 15 days or until there are no longer signs of new feeding by mice or meadow voles.

FOLLOW-UP: Replace contaminated or spoiled bait immediately. Using barrier laminate gloves collect and dispose of all dead, exposed animals and leftover bait properly. To discourage reinfestation, limit sources of rodent food, water and harborage as much as possible. If reinfestation does occur, repeat treatment. Where a continuous source of infestation is present, establish permanent bait stations and replenish as needed.
