Additional Sticker Labeling

Purpose

This submission revises the labeling for this product, under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA) to add additional restrictive texts on a sticker label.

Review

The State of Washington requested that you add the following additional text to the labeling for this product as a sticker:

Do not apply Prozac Zinc Phosphide Pellets (EPA Reg. No. 61282-49) to timothy or timothy/alfalfa mixtures within 60 days of harvest.

The reason for this text is that it reflects the data developed by IR-4 for this use. Originally, you had proposed no pre-harvest interval (PHI) while IR4 had proposed one of 120 days. Washington State later recommended a PHI of 60 days. We accept this PHI on an interim basis and will let you know if it needs to be modified at a later date. At that time, we may have suggestions for more label improvements to make the presentation clearer.

The State of Washington also requested that you add the following additional text to the labeling for this product as a sticker:

Do not apply Prozac Zinc Phosphide Pellets (EPA Reg. No. 61282-49) to timothy/clover mixtures.

The reason for this change is that there is no tolerance for clover in 40 CFR 180.284 other than one to be used under section 18 (Emergency Exemption), which expires on December 31, 2005.

Until the Agency approves a tolerance on clover, you must use the sticker in the interim and delete the mention of this site from your label at your next printing.

Sticker approval

The sticker labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, is acceptable. Enclosed is a stamped version of the text.

Existing Stocks

The sticker must appear on all existing stocks of labels for this product, regardless of where you intend to ship the product. Within 18 months of this letter, you must incorporate the text on the sticker label to your final printed label. The minimum type size is 12 point.

Consequence for non-compliance

This registration will be subject to cancellation in accordance with FIFRA sec. 6(e) if you do not comply with this condition. Your release for shipment of the product bearing the amended labeling constitutes acceptance of this condition.

A stamped copy of the sticker labeling is enclosed for your records.
