LAWNS, GOLF COURSES, OTHER NON-CROP AREAS TO CONTROL MOLES AND POCKET GOPHERS

Use Restrictions: This product may be used in lawns, golf courses, and other non-crop areas only to control pocket gophers and moles. All bait applications in these areas must be made directly into underground humles made by moles or pocket gophers. All bait must be applied manually (e.g., by gloved hand or hand probe delivery system) as directed below. Do not apply this product by use of a burrowbuilder machine. Do not apply in gardens and areas where food or feed might be contaminated. Collect and bury all dead animals found above ground.

<u>Specific Directions for Moles</u>: The presence of moles may be indicated by a network of surface ridges in the turf, by a series of conical mounds of earth pushed up from deep burrows, or by damage to bulbs.

Surface Ridges: Frior to treatment determine which burrows are repeatedly active. To do this, either press down a small section of the tunnel or remove a one inch section of the tunnel's roof. Mark these sections and check them in 24 hours. The burrow is considered active if the flattened runway has been reised up or the roof has been repaired. Only treat active burrows. Carefully punch a hole in the top of active tunnels, drop a teaspoon amount of this product through the hole and carefully close the hole with sod or stone. Do not collapse the runway again or allow loose soil to cover the bait. After a few days check to see if the burrows are still active according to one of the two methods described above. If so, repeat treatment. If mole activity persists after two treatments, abandon use of this product and seek another method of controlling moles.

Conical Mounds: Carefully remove the center plug from each conical mound. Drop a teaspoon amount of this product into the underground tunnel. Close the opening with a rock or sod. Do not allow loose drit to cover bait. If mole activity persists after one treatment, a second treatment may be made. If mole activity persists after two treatments, abandon use of this product and seek another method for controlling moles.

<u>Specific Directions for Pocket Cophers:</u> Burrowing pocket gophers (*Thomonys spp.* and *Geomys spp.*) throw out low, fan shaped dirt mounds on either side of their underground tunnels. Lateral tunnels coming to the surface on the flat side of the fan are plugged with soil. Carefully remove the plug. With a longhandled spoon, insert a tenspoon amount of this product as far down as possible. Re-close opening with sod, soil, or a rock, being careful not to cover bait.

#### IN AND AROUND BUILDINGS

TO CONTROL RATS AND MICE

Important: Do not expose children, pets, or other nontarget animals to rodenticides. To help to prevent accidents:

- 1. Store product not in use in a location out of reach of children and pets.
- Apply bait in locations out of reach of children, pets, domestic animals and nontarget wildlife, or in tamper-resistant bait stations. These stations must be resistant to destruction by dogs and by children under six years of age, and must be used in a manner that prevents such children from reaching into bait compartments and obtaining bait. If bait can be abked from stations
- from reaching into bait compartments and obtaining bait. If bait can be shaken from stations when they are lifted, units must be secured or otherwise immobilized. Even stronger bait stations are needed in areas open to hoofed livestock, raccoons, bears, or other potentially destructive animals, or in areas prone to vandalism.
- Dispose of product container, and unused, spoiled, and unconsumed bait as specified on this label.

<u>Use Restrictions:</u> This product may be used in and around homes, industrial, agricultural and commercial buildings, and similar manmade structures to control Norway rats, roof rats or house mice. Do not place this product in areas where there is a possibility that it will contaminate food or surfaces that come in direct contact with food. Do not broadcast bait.

Selection of Treatment Areas: After removing as many sources of food for rodents as possible, determine dry, acid-free areas where rats and mice will most likely find and consume the bait. Generally, these areas are along walls, by gnawed openings, in or beside burrows, in corners and concealed places, between floors and walls, or in other locations where signs of rats or mice have been seen. Protect bait from rain or snow. Baltime:

#### Rate: Apply 1 to 2 teaspoons (4 to 8 grams) of this product per placement. Space placements at intervals of 15 to 30 feet along vertical surfaces in infested area. Maintain an uninterrupted supply of fresh bait until new signs of feeding by rats have ceased to anopear.

Mice: Apply 1 teaspoon (4 grams) of bait per placement. Space placements at intervals of 8 to 12 feet along vertical surfaces in infested areas. Maintain an uninterrupted supply of fresh bait until signs of new feeding by mice no longer appear.

Follow-up (Rats & Mitce): Replace contaminated or spoiled bait immediately. Collect and properly dispose of all dead animals and leftover bait. To discourage reinvasion, limit sources of rodent food, water and harborage as much as possible and close off likely routes of entry into structures. Do not retreat the same area with this product at intervals of less than 30 days from end of the previous treatment period.

### STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. Household Label

Pesticide Storage: Store in original container in a cool, dry place inaccessible to children and pets.

If empty: Nonrefillable container. Do not reuse this container. Place in trash or offer for recycling if available.
