- 3. Submit one copy of the final printed label for the record before you release the product for shipment.
- 4. If, after formal consultation with the appropriate Service(s), additional modifications are identified in the Service's Biological Opinion(s) for bromethalin, EPA will notify Hacco Inc. in writing consistent with the terms in the Biological Opinion of any necessary required changes. Hacco Inc. must submit an application for amendment incorporating any required changes, including amended labels, consistent with the timeline specified in EPA's notification. If Hacco Inc. fails to comply with this term, Hacco Inc. has agreed in prior written acceptance on May 28, 2025 of these terms that EPA may cancel the registration under an expedited process under FIFRA 6(e).

For indoor use only. This product may only be used to control house mice in homes and residential buildings.

**USE RESTRICTIONS:** Do not use this product in sewers or any outdoor area. Do not place this ready-to-use bait station in any area where there is a possibility of contaminating food or surfaces that come into direct contact with food. Do not place near or inside ventilation duct openings. Do not break open and/or deliberately remove bait from station. Do not sell this product in individual containers holding more than 1 pound of bait.

**SELECTION OF TREATMENT AREAS:** Determine areas where mice will most likely find and consume the bait. Generally, these areas are along walls, by gnawed openings, in corners and concealed places, between floors and walls, or in locations where rodents or their signs have been seen. Remove as much alternative food as possible.

#### **APPLICATION DIRECTIONS:**

The active ingredient in this product is different from anticoagulant rodenticides. Individual mice cease feeding after consuming a toxic dose.

**House Mice:** Place a single unit at each placement location. Space placements at 8-to-12-foot intervals. Highest bait consumption is expected to occur on the first day or two after treatment. After several days, while wearing gloves, inspect bait placements and replace with new bait at sites where there is heavy feeding or where there is continued evidence of house mouse activity. Continue baiting until all signs of house mouse activity have ceased. Replace units if contents are consumed or contaminated, or if units are severely damaged.

#### Follow-Up:

Wearing gloves, collect and properly dispose of all dead house mice and used bait station. To discourage reinfestation, limit sources of food, water, and harborage as much as possible. If reinfestation does occur, repeat treatment.

#### STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

**Pesticide Storage:** Store in original container in a cool, dry place inaccessible to children and pets. Keep containers closed and away from other chemicals.
