so as to be vulnerable to commensal rodent invasions and/or harboring or attracting rodent infestations. Fence and perimeter baiting beyond 100 feet from an agricultural structure as defined above is prohibited. This product must not be applied directly to food or feed crops. Do not broadcast bait.

Do not use in homes or other human residences. Do not place near or inside ventilation duct openings. Do not contaminate water, food, feedstuffs, food- or feed-handling equipment, milk- or meat-handling equipment, or surfaces that come into direct contact with food. When used in USDA-inspected facilities, this product must be applied in tamper-resistant bait stations. Do not use in sewers.

This product may also be applied to active rodent burrows to control Norway rats and roof rats *within* 100 feet of buildings and man-made structures, provided that infestations of these rodents have been confirmed.

Efforts should be made to remove food trash, garbage, clutter, and debris.

Bait must be placed not less than 6 inches into active Norway/roof rat burrows.

## **SELECTION OF TREATMENT AREAS**

Determine areas where rats and/or mice will most likely find and consume the bait. Generally, these areas are along walls, by gnawed openings, in or beside burrows, in corners and concealed places, between floors and walls, or in locations where rodents or their signs have been observed. Remove as much food as possible.

## **APPLICATION DIRECTIONS**

### **Norway and Roof Rats**

Apply 4–16 oz. of bait (usually at intervals of 15–30 ft.) per placement. Bait must be placed not less than 6 inches into active Norway/roof rat burrows. Maintain an uninterrupted supply of fresh bait for 10 days or until signs of rat activity cease.

### **House Mice**

Apply ¼–½ oz. of bait per placement. Space placements at intervals of 8–12 ft. Larger placements (up to 2 oz.) may be needed at points of very high mouse activity. Maintain an uninterrupted supply of fresh bait for 15 days or until signs of mouse activity cease.

### **Follow-Up**

Replace contaminated or spoiled bait immediately. Collect and dispose of all dead rodents and leftover bait properly. To prevent reinfestation, limit sources of rodent food, water, and

harborage as much as possible. Where a continuous source of infestation is present, maintain permanent bait stations and replenish with census or toxic bait as needed.
