The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable. However, EPA reviewed only the label changes highlighted, marked, or otherwise indicated on the submitted label. Any other changes to the previously approved label that were not clearly highlighted, marked, or otherwise indicated in your submission were not reviewed and may form the basis of regulatory and/or enforcement action if later discovered by the Agency. Further, submission of a label amendment application with unidentified changes may be considered a knowing submission of false information to the Agency. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

The label submitted with the application has been stamped "Accepted Only Indicated Revisions Reviewed" and is enclosed for your records.

The alternate brand names, "**SureKill Brand Talon Weatherblox XT**" has been added to the product record.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under FIFRA and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) lists examples of

In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Compliance.

Additionally, if after formal consultation with the appropriate Service(s), additional modifications are identified in the Service's Biological Opinion(s) for Brodifacoum, EPA will notify Hacco in writing consistent with the terms in the Biological Opinion of any necessary required changes. Hacco must submit an application for amendment incorporating any required changes, including amended labels, consistent with the timeline specified in EPA's notification. If Hacco fails to comply with this term, Hacco has agreed in prior written acceptance of these terms on 12/08/2025 that EPA may cancel the registration under an expedited process under FIFRA 6(e).

Your release for shipment of the product constitutes acceptance of these conditions. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6.

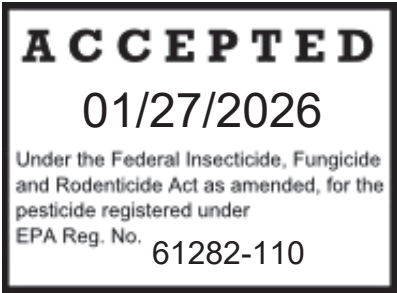

Examples of such structures include homes and other permanent or temporary residences, food-processing facilities, industrial and commercial buildings, trash receptacles, agricultural and public buildings, transport vehicles (ships, trains, aircraft), docks, and port of terminal buildings and related structures around and associated with these sites. Fence and perimeter baiting beyond 100 feet from a structure as defined above is prohibited. This product must not be applied directly to food or feed crops. Do not broadcast bait.

Do not place near or inside ventilation duct openings. Do not contaminate water, food, feedstuffs, food- or feed-handling equipment, or milk- or meat-handling equipment or surfaces that come into direct contact with food. When used in USDA-inspected

Determine areas where rats and/or mice will most likely find and consume the bait. Generally, these areas are along walls, by gnawed openings, in corners and concealed places, between floors and walls, or in locations where rodents or their signs have been observed. Remove as much food as possible.

### **NORWAY AND ROOF RATS**

Apply 4–22 [(20 gm (0.7 oz))] blocks of Talon Weatherblok XT (usually at intervals of 15–30 ft) per placement. Maintain an uninterrupted supply of fresh bait for 10 days or until signs of rat activity cease.

For use in sewers, securely attach one end of wire to Talon Weatherblok XT and the other end to a stationary structure such as the bottom step of a manhole ladder or to a sewer grate, allowing just enough wire for the block to rest on manhole benching. If benching is not present, suspend block a few inches above the high water line or place Talon Weatherblok XT on a board supported by opposing steps of the ladder. Securing Talon Weatherblok XT in this manner will prevent removal by rats or water. Maintain an uninterrupted supply of fresh bait for at least 10 days or until signs of rat activity cease.

### **HOUSE MICE**

Apply 1 bait block per placement. Space placements at intervals of 8–12 feet. Two blocks may be needed at points of very high mouse activity. Maintain an uninterrupted supply of fresh bait for 15 days or until signs of mouse activity cease.

### **FOLLOW-UP**

Replace contaminated or spoiled bait immediately. Collect and dispose of all dead animals and (when baiting operations are to be ceased) unconsumed bait according to the **Pesticide Disposal** instructions. To prevent re-infestation, limit food, water and harborage as much as possible. If re-infestation does occur, repeat treatment.
