3. Submit five (5) copies of your final printed labeling before you release the product for shipment. Refer to the A-79 enclosure for a further description of final printed labeling.

Chlorine is a non-flammable gas liquefied under pressure. Do not drop container. Keep away from intense heat and open sunlight. Corrosive to most metals in the presence of moisture

DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with the labeling. Have available gas masks approved by the US Bureau of mines or the National Institute of Occupational Safety and Health. Handle and use only in accordance with Practices recommended in the Chlorine Manual published by the Chlorine Institute, Inc. Use only in well ventilated areas. Only specially designed dispensing equipment should be used, in accordance with manufacturer's instructions and with the Chlorine Institute's recommendations. Dosages of residual chlorine levels which should be maintained for any specific site of application must be consistent with state and municipal recommendations.

STORAGE AND DISPOSAL

Cylinders should be stored in a dry area away from sources of heat and protected from direct sunlight and precipitation. Cylinders must not be stored where they will be exposed to temperatures warmer than 54.5°C (130°F). They should be segregated from other compressed gases and never stored near hydrocarbons, finely divided metals, turpentine, ether, anhydrous ammonia or other flammable materials. All cylinders must have a weather resistant label attached near the outlet valve and must not be accessible to the public. Empty cylinders to be returned should be identified with a DOT tag or label and shipped in accordance with practices of the supplier and the Chlorine Institute. All valves must be closed tight and closures or caps secured. If container is damaged, or if the contents are leaking, notify SISTER H CORPORATION, D/B/A, TEXAS POOL CHEMICAL immediately at (817) 860-3233.
