It is not intended for home and farm use and must not be used for pressure or thermal treated logs used in the construction of log homes except laminated beams or building components which are in ground contact and are subject to decay or insect infestation and where two coats of an appropriate sealer are applied. Urethane, shellac, latex, epoxy, enamel and varnish are acceptable sealers for pentachlorophenol treated wood.

This product may be used to formulate products for specific use(s) not listed on the MP label if the formulator, user group, or grower has complied with U.S. EPA submission requirements regarding support of such uses(s).

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.
