Subject: Proposed label amendment for the following revisions: Add Use Restrictions section to comply with 2002 TRED, add new EPA Reg. No. and EPA Est. No(s), update First Aid Statements, change registrant name and address to reflect KMG-Bernuth ownership, revise Warranty Statement, revise Environmental Hazards Section, and revision and consolidation of Storage and Disposal Statements.

Dear Dr. ONeal;

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), is acceptable subject to the comments listed below. Five copies of the finished labeling must be submitted prior to releasing the product for shipment.

- 1. Page 3 of 4:
 - a. Move the Chemtrec box (shown below) out of the "Hazards to Humans and Domestic Animals" section and unto the front panel of the label.

FOR CHEMICAL EMERGENCY. Spill, leak, fire, exposure, or accident call CHEMTREC 1-800-424-9300.

b. Revise the Personal Protective Equipment section as follows:

"Personal Protective Equipment (PPE)

"Some materials that are chemical-resistant to this product are". "If you want more options, follow the instructions for category ² on an EPA chemical-resistance category selection chart."

Loaders, mixers and handlers must wear:

- long-sleeved shirt and long pants
- Shoes plus socks
- Chemical resistant gloves

⁽registrant inserts correct chemical-resistant material)

² [registrant inserts A,B,C,D,E,F,G,or H]

- Protectice eyewear
- Chemical-resistant apron when cleaning equipment, mixing or loading."
- c. Insert the User Safety Recommendations section within a box as follows:

USER SAFETY RECOMMENDATIONS

Users should:

Wash hands before eating, drinking, chewing gum, using tobacco or using the toilet. Remove clothing immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing. Remove PPE immediately after handling this product. Wash the outside of gloves before removing. As soon as possible, wash thoroughly and change into clean clothing.

d. Revise the Environmental Hazards section per the TRED as follows:

"ENVIRONMENTAL HAZARDS

This product is highly toxic to fish. Do not discharge effluent containing this product into lakes, streams, ponds, estuaries, oceans, or other waters unless in accordance with the requirements of a National Pollutant Discharge Elimination System (NDPES) permit and the permitting authority has been notified in writing prior to discharge. Do not discharge effluent containing this product to sewer systems without previously notifying the local sewage treatment plant authority. For guidance contact your Water Board or Regional Office of the EPA."

2. Page 4 of 4:

- a. Within the Directions for Use, the following statement: "Refer to "RABON Technical Bulletin" for formulating and other information." requires the submission of the Rabon Technical Bulletin as part of the full label approval, or KMG-Bernuth, Inc. may remove this statement from the label.
- b. Within the Use Restrictions sub-section make the following corrections:

Revise the Horse Restriction language as follows:

"Do not formulate or manufacture this product into feeds for use on horses intended for slaughter.

All end use products formulated for use on horses must contain the following language:

USE RESTRICTIONS

For Use on Horses:

Do not feed this product to horses intended for slaughter.

This product contains tetrachlorvinphos, which is a cholinesterase inhibitor. The most frequently reported clinical signs of cholinesterase inhibition in the horse are abdominal pain, lethargy, sweating, tearing and excessive salivation. If these signs are seen in horses, consult your veterinarian immediately. Do not use this product simultaneously or within a week before or after treatment with cholinesterase inhibiting drugs, pesticides or chemicals. Consult a veterinarian before using this product on debilitated, aged, pregnant or nursing animals. This product has not been tested in breeding horses."

Delete the following subsection statements including headers:

"For Pet Powder Products: Use 1/3 oz. of powder per every 10 pounds of body weight of your cat or dog.

For Outdoor Premise Products: Restrict uses to only spot treatments. The product should be applied only one time per year. The product is to be used along woody borders of kennels, yard, campgrounds, recreational parks, and footpaths and roadways leading to such areas."

These statements are not applicable for a manufacturing use product, and further manufacturing into pet power and outdoor premise products, would require EPA registration. Applicable labeling language would be added to the end-use product at that time.
