The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable with the following label revision provision(s):

First Aid section comment(s), page 1 of 4:

1. Revise the 2nd sentence within the "**HOTLINE NUMBER**" subsection to read "**For additional information on this pesticide product (including health concerns, medical emergencies or pesticide incidents), you may call CHEMTREC at 1-800-424-8177, 24 hours per day, 7 days per week.**"

Storage and Disposal Statement section comment(s), page 4 of 4:

2. Revise the existing "**PESTICIDE STORAGE:**" subsection to read "**PESTICIDE STORAGE:** Store product in its original container in a cool, dry place in an area that is inaccessible to children and animals."
3. Revise the existing "**CONTAINER DISPOSAL:**" subsection to read "**CONTAINER DISPOSAL:** Nonrefillable container. Do not refill or reuse empty liner. Completely empty liner by shaking and tapping sides and bottom to loosen any clinging/remaining particles into application equipment. Dispose of empty liner in a sanitary landfill, or incinerate, or by other procedures approved by state and local authorities. If drum is contaminated and cannot be reused, dispose of in the same manner."

Please submit two (2) copies of the final printed labeling, incorporating the above changes, before releasing the product for shipment. If these conditions are not complied with, the registration will be subject to cancellation in accordance with section 6(e) of FIFRA. Use only for formulation into an insecticide/Larvicide for the following: (1) uses as a feed additive in the feeds for cattle (beef & dairy, including lactating), swine, horses and mink to prevent the development of fecal flies; (2) uses for which EPA has accepted the required data and/or citations of data that the formulator has submitted in support of registrations; and (3) uses for experimental purposes that are in compliance with US EPA requirements.

USE RESTRICTIONS

Do not formulate or manufacturer this product into feeds for use on horses intended for slaughter.

The most frequently reported clinical signs of cholinesterase in the horse are abdominal pain, lethargy, sweating, tearing and excessive salivation. If these signs are seen in horses, consult your veterinarian immediately. Do not use this product simultaneously or within a week before or after treatment with cholinesterase inhibiting drugs, pesticides or chemicals. Consult a veterinarian before using this product on debilitated, aged, pregnant or nursing animals. This product has not been tested in breeding horses.

STORAGE AND DISPOSAL

DO NOT contaminate water, food or feed by storage or disposal.

PESTICIDE STORAGE: Store in cool dry location in original container.

PESTICIDE DISPOSAL: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility. Open dumping is prohibited.

CONTAINER DISPOSAL: Nonrefillable container. Completely empty liner by shaking and tapping sides and bottom to loosen clinging particles. Empty residue into mixing equipment.
