Dear Dr. O'Neal:

We have reviewed the above referenced submission, in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended. The labeling is acceptable with the following comments:

- Change the EPA Reg. No. from 61483-55 to 61483-53
- Under Precautionary Statements:
 - Revise the statement "Wash thoroughly with soap and water after handling" to read "Wash throughly with soap and water after handling and before eating, drinking, chewing gum, or using tobacco."
 - After precautionary statements, add "Sensitivities may occur after using ANY pesticide products for pets. If signs of sensitivity occur, remove collar and bathe the pet with mild soap and rinse with large amounts of water."
- Under General Precautions and Restrictions, add "Do not use this product on animals simultaneously or within 30 days before or after treatment with or exposure to cholinesterase inhibiting drugs, pesticides or chemicals. Flea and tick collars may be immediately replaced with new collars."

Do not use on puppies under 6 weeks. Consult a veterinarian before using this product on debilitated, aged, or medicated animals. If used on pregnant or nursing dogs, do not replace collar until the puppies are at least 6 weeks old. If signs of sensitivity occur, remove collar and bathe your pet with mild soap and rinse with large amounts of water.

APPLICATION INSTRUCTIONS

Remove collar from package, unroll and stretch to activate insecticide generator. To activate collar, hold at each end and STRETCH. The collar is ready to work.

Do not unroll collar until ready to use. Place the Americare Rabon Flea & Tick Collar around the dog's neck, adjust for proper fit and secure in place. The collar must be worn loosely to allow for growth of the dog and to permit the collar to move about the neck. Generally, a properly fitted collar is one that when fastened will snugly slide over the dog's head. Leave 2 or 3 inches on the collar for extra adjustment and cut off and dispose of the extra length. Some animals may become irritated by any collar if it is applied too tightly. If this occurs, loosen the collar. If the irritation continues, remove the collar from the animal. This collar is intended for use only as an insecticide generator.

Kills fleas and ticks common to dogs. The Americare Rabon Flea & Tick Collar will begin to kill fleas and ticks immediately. It's full protection against harder to kill ticks will be built up within a few days after being placed on the pet. For continuous flea and tick protection under normal conditions, replace the collar every 5 months. Under conditions where dogs are exposed to severe flea or tick infestations, it may be necessary to replace the collar more frequently, however do not replace the collar more frequently than every 4 months. Wetting will not impair the collar's effectiveness or pet's protection. If the dog goes swimming or is out in the rain, it is not necessary to remove the collar. The Americare Rabon Flea & Tick Collar may be worn with a regular collar.
