BEEF & DAIRY CATTLE

Horn Flies, Lice, Face Flies: Place contents of this package in any commercially available dust bag, suspend bags in areas frequented by cattle or in gateways of lanes through which the animals pass daily for water, feed or minerals. For lactating dairy cows, bags may be suspended in the exit through which cows leave the milking barn. In all cases, the bags should be adjusted so that the bottom of the bag will hang four to six inches below the topline of the cattle. For eduction of face flies, the bags must be located so the animals will be forced to use them daily and hung at a height to insure that the faces of the cattle will be dusted.

Horn Flies, Lice – Direct Application: Apply 2.0 ounces of dust per animal by shaker can over the head, neck, shoulders, back and tailhead. Repeat as necessary.

POULTRY

Northern Fowl Mites – Direct Application: Apply not more than 1lb/100 birds, directing dust to thoroughly cover vent area.

SWINE

Lice on Swine – Direct Application: Apply not more than 1 ounce* (3 level tablespoons) per head as a uniform coat to the head, shoulders and back by use of a shaker can or suitable mechanical dust applicator. Repeat as necessary, but not more often than once every ten days.

In severe infestations, both individual animals and the bedding may be treated as directed above.

Do not ship animals for slaughter within 5 days of last treatment.

*NOTE: 1 ounce of this material equals approximately three level tablespoonfuls.

STORAGE AND DISPOSAL

DO NOT contaminate water, food or feed by storage or disposal.

PESTICIDE STORAGE: Open as needed. Keep container sealed when not in use.

PESTICIDE DISPOSAL: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility
