Instructions for all methods of application: Keep away from eyes and mucous membranes of animal being treated. Repeat treatment as needed, but do not apply more than once every two weeks

A 64 ounce container will treat up to 63 animals.

A 2.5 gallon container will treat up to 315 animals.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

Storage: Keep container sealed when not in use. Do not store near food or feed.

Pesticide Disposal: Wastes resulting from the use of this product must be disposed of on site or at an approved waste disposal facility.

Container Disposal: Nonrefillable container. Do not reuse or refill this container. Triple rinse container (or equivalent) promptly after emptying. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Fill the container ¼ full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times. Offer for recycling, if available, or puncture and dispose of in a sanitary landfill, or incineration, or if allowed by local authorities, by burning. If burned, stay out of smoke.
