The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended is acceptable provided that you:

1. Make the labeling changes listed below before you release the product for shipment bearing the amended labeling:

a. Move the heading "Precautionary Statements" to a separate line above the subheading "Hazards to Humans and Domestic Animals".

b. Modify the Statements Of Practical Treatment to read:

IF ON SKIN: Wash with plenty of water. Get medical attention if irritation persists.

IF IN EYES: Flush eyes with plenty of water. Call a physician if irritation persists.

2. Submit one (1) copy of your final printed labeling before you release the product for shipment.

A stamped copy of the labeling is enclosed for your records.

The revised basic formula is acceptable and has been included in the files for this product. It supersedes all previously accepted ones.

#### Storage And Disposal

Do not contaminate water, food or feed by storage or disposal. Store in cool place. Prolonged exposure of chemical to air or sunlight may result in darkening of the product and staining of the fruit. Dispose of on site trash collection or at approved waste disposal facility. Open dumping is prohibited.
