The application referred to above, submitted under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable under FIFRA §3(c)(7)(B) subject to the following conditions:

2. If you fail to satisfy these data requirements, EPA will consider appropriate regulatory action, including, among other things, cancellation under FIFRA §6(e).

A stamped copy of the label is enclosed for your records. The main label supersedes all previously accepted labels. You must submit one (1) copy of the final printed label before you release the product for shipment. Products released for shipment after eighteen (18) months from the date of this letter must bear the new revised label. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA §6(e). Your release for shipment of the product constitutes acceptance of these conditions.

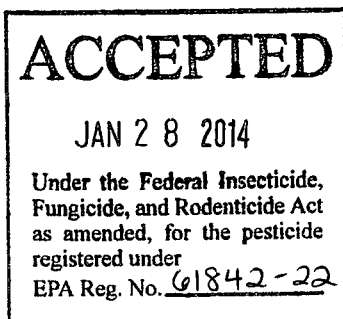
