OUTDOOR USE: Spray perimeter of home generously to make a barrier of protection. Spray doorways, window frames, cracks - anywhere an insect can enter. Saturate until visibly wet. Saturate areas of trail or nests. Spray garbage cans, manure piles or any infested areas until visibly wet.

STORAGE AND DISPOSAL Do not contaminate water, food or feed by storage and disposal. Storage: Store only in original container in a cold dry place, inaccessible to children and domestic animals. Disposal: If empty: Do not reuse this container. Place in trash or offer for recycling if available. If partially filled: Call your local solid waste agency for disposal instructions. Never place unused product down any indoor or outdoor drain.
