3. Submit a Storage Stability test (E3-17) for this product. This study is due November 1, 1992.

4. Add the phrase "EPA Registration No. 61966-2" to your label before you release the product for shipment.

5. Submit five (5) copies of your final printed labeling before you release the product for shipment. Refer to the A-71 enclosure for a further description of final printed labeling.

#### DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

#### INDOORS

##### Use restrictions

Do not use on fabric or carpet as stains will result. Apply only in areas inaccessible to children and pets. Avoid contamination of feed and food stuffs. Not for use in kitchens.

#### FOR DOMESTIC (HOMEOWNER) USE ONLY

General: Product is for the control of adult insects. Use stream setting. Apply at 0.07 oz. (approximately 2 full trigger sprays) per sq. ft.

COCKROACHES, WATERBUGS, SILVERFISH, CRICKETS, EARMIGS, CENTIPEDES, MILLIPEDES: Spray until wet in cracks and crevices, around baseboards, behind and beneath cabinets and appliances, around plumbing, and other localized areas infested with insects. After application, any product that is accessible to children and pets or that may contaminate feed and food stuffs must be wiped off. Repeat as necessary.

ANTS: Spray until surface is wet. Apply to ant trails, around doors and window frames and wherever ants enter the house. After application, any product that is accessible to children and pets or that may contaminate feed and foodstuffs must be wiped off. Repeat as necessary.

SPIDERS: Spray pests directly wherever possible. Apply to localized areas where infestations occur. Spray until surfaces are wet, particularly around windows, doors, baseboards and crawl spaces. After application, any product that is accessible to children and pets or that may contaminate feed and foodstuffs must be wiped off. Repeat as necessary.

#### OUTDOORS - NON FOOD

ANTS: Thoroughly wet hill and runways. Spray around walkways, porch, patios and foundations to prevent insect infestation. Repeat applications as infestations warrant and as reinfestations occur.

#### PRECAUTIONARY STATEMENTS

##### Hazards to Humans and Animals
