This dual action formula keeps dogs and cats from walking on carpeting and lying on upholstered furniture. It also leaves your room smelling clean and lemon-fresh.

DIRECTIONS FOR USE

It is a violation of federal law to use this produce in a manner inconsistent with its labeling.

USE RESTRICTIONS

Prior to applying product, test a small portion of the carpet or fabric to insure that the product will not stain the material. Avoid use on wet areas. If product adheres to a spot, rub with a stiff brush. Do not sprinkle directly on humans or animals.

APPLICATION DIRECTIONS

Remove children and pets from the areas to be treated. Sprinkle carpet freshener evenly over desired areas. Apply 2 grams (approximately 1 teaspoon) per sq. ft. For best results, entire area to be protected must be covered. Leave product on treated area for 15 minutes, then vacuum.

Reapply when vacuuming each 36 hours to maintain repellent effect. May be used for a temporary control. Apply as needed.

PRECAUTIONARY STATEMENTS

Hazards to Humans and Animals

CAUTION: Avoid contact with skin or eyes. May cause burning sensation to skin, eyes or nose due to Capsicum oleoresin.

Statement of Practical Treatment

If on skin, wash with soap and water. If in eyes, flush with plenty of water. Get medical attention if irritation persists.
