This product replaces a previously registered product, Carpet Freshener, EPA Reg. No. 61966-2, which the Agency cancelled on July 24, 1996 for failure to pay the 1996 Maintenance Fee. At the time of cancellation, the Agency was in the process of bringing that product up to current standards through the re-registration process initiated in 1992. In 1994, the Agency had identified certain outstanding data and information needed to meet current standards. Those outstanding requirements are included as conditions to this registration.

This product is conditionally registered in accordance with FIFRA sec. 3(c) (7) (A) provided that you:

A. Within 90 days of receipt of this letter, you submit the following documents:

1. Revised Confidential Statement of Formula (CSF) with the following changes:

- a. Block 10 (Components in Formulations)

These are the actual components introduced into your product during manufacture. Your 9/21/96 CSF indicates that you introduce "Allyl Isothiocyanate" into your product when in fact you are introducing "Oil of Mustard". You need to clarify this entry as follows:

Oil of Mustard (Active ingredient is "Allyl Isothiocyanate")

For the same reason, you need to clarify the listing for the third ingredient as follows:

Oleoresin of Capsicum (Active ingredient is "Capsaicin and Related Capsaicinoids")

2. Submit a chemical analysis of your product for both actives, using the HPLC methods submitted for EPA File Symbol 61966-U. If the nominal concentrations for either active differs from that on your formula dated May 13, 1996 and label, submit a revised CSF and label to correct the error.
 3. Submit a Certification Statement for this product. We assume that you will be selecting the "Selective Method" since you have your own data.
 4. Submit a data matrix for this product, listing the MRID numbers supporting your product chemistry, acute toxicity, and effectiveness data (public health uses).
 - B. Within 90 days of receipt of this letter, you need to do one of the following:
 1. commit to doing an eye irritation and skin irritation test for this product
 2. request voluntary cancellation, or
 3. submit an acceptable rationale showing that data for 61966-5 and -7 should apply to 61966-6.
 - C. Make the labeling changes listed below and submit one (1) copy of final printed labeling before you release the product for shipment:
 1. Add "EPA Reg. No. 61966-6" to your label.

2. In the ingredient statement, change "Related Compounds" to "Related Capsaicinoids".
3. Change the heading "Statement of Practical Treatment" to "First Aid".

This registration will be subject to cancellation in accordance with FIFRA sec. 6(e) if you do not comply with these conditions. Your release for shipment of the product constitutes acceptance of these conditions.

Our Carpet Freshener with pet guard uses only extracts of mint and essential oil of mustard to create a unique and effective animal repellent. This fast action formula keeps dogs and cats from walking on carpeting and other upholstered furniture. It also leaves your room smelling clean and fresh.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

USE RESTRICTIONS

Prior to applying product, test a small portion of the carpet or fabric to insure that the product will not stain the material. Avoid use on wet areas. If product adheres to a spot, rub with stiff brush. Do not sprinkle directly on humans or animals.

APPLICATION DIRECTIONS

Remove children and pets from the area to be treated. Sprinkle carpet freshener evenly over desired areas. Apply 2 grams (approximately 1 teaspoon per sq. ft. For best results, entire area to be protected must be covered. Leave product on treated area for 15 minutes, then vacuum.

Reapply when vacuuming each 36 hours to maintain repellent effect. May be used for a temporary control. Apply as needed.

PRECAUTIONARY STATEMENTS

Hazards to Humans and Animals

CAUTION: Avoid contact with skin or eyes. May cause burning sensation to skin, eyes or nose due to Capsicum Oleoresin.

STATEMENT OF PRACTICAL TREATMENT
