#### **GENERAL INFORMATION**

- Use only as directed. The label should be read thoroughly and understood before making applications. For best results, trials should be conducted to determine desired rates and timings for optimum responses under local growing conditions and with specific varieties.
- The term 'grams of active ingredient per acre' is represented by 'g ai/acre' throughout this product label.
- All parts of the plant or crop should be covered by the spray to obtain the desired result.
- Prepare solution concentrations by mixing the required amount of product with water only in a clean empty spray tank.
- Any unused spray material at the end of the day must be disposed of following local, State or Federal law.
- When a range of rates is indicated use the concentration and spray volume recommended locally. Consult your local experimental station or distributor for spray program best suited to your conditions.
- FLORGIB 4L works best when using water of neutral or slightly acidic pH. Water should always have a pH of less than 8.5.
- Absorption of FLORGIB 4L into the plant is greatest under slow drying conditions. Night-time applications will be more effective when day-time conditions cause rapid drying. FLORGIB 4L should be re-applied if significant rain occurs within 2 hours of application
- Data concerning the compatibility of FLORGIB 4L is not available.

## **APPLICATION GUIDE**

Bermuda Golf Turf - Application of FLORGIB 4L can be used to initiate or maintain growth and prevent color change during periods of cold stress. Make one application of 10 g ai weekly or 25 g ai in 25 – 100 gallons of water/acre every 2 weeks. Do not exceed these recommended doses or reduce the time interval between applications. Do not apply during extended warm periods if night temperatures exceed 65°F. Continue good ground keeping practice and stop treatment if thinning of the grass occurs. Do not use on dormant turf.

**Pompom Chrysanthemums -** Application of FLORGIB 4L elongates the peduncles. Make one application of 0.5 – 1 g ai in 12 gallons of water 28 – 35 days after initiation of short day program. Apply this solution over 1000 sq.ft. of about using overhead nozzles directed at the flower buds. Apply at the correct timing and do not overdose as this can cause long, spindly, weak stems.

**Statice -** Application of FLORGIB 4L promotes early flowering and increases flower yield. Make one application of 40 – 50 g ai in 25 gallons of water when plants are more than 10 inches in diameter (approx. 90 – 110 days after planting). Apply 10 ml of spray as a drench to each plant. Do not exceed the recommended dose or repeat treatment. Initiation of flowering is influenced by extended photo-period, nutrition and reduced night temperature. Treatment with FLORGIB 4L lessens the need for reduced night temperature and long photo-period.

Cala Lillies (Zantedesia sp.) – Application of FLORGIB 4L by soak, spray or field drench increases flowering, controls height, and shortens days to flowering. As a soak, use a 100 ppm to 500 ppm solution. Spray applications are generally made at concentrations between 50 and 100 ppm to plants to stimulate flowering. Field drench is made over the planted bulbs at 100 - 500 ppm. For best results, trials should be conducted to determine desired rates and timings for optimum responses under local growing conditions.

**Tropical Foliage** – For application to plants such as *Aglanomema commutatum*. Apply FLORGIB 4L to induce uniform flowering. Recommended dosages range from 100 – 400 ppm applied as a spray solution to runoff. Generally, treatment is used to induce flowering so breeding and cross pollinations can be carried out. For best results, trials should be conducted to determine desired rates and timings for optimum responses under local growing conditions.

**Geranium (***Pelargonium* **sp.)** - Application of FLORGIB 4L to rooted cuttings will stimulate root growth and development when added directly to hydroponic nutrient solution. Applications of between 0.5 ppm and 50 ppm are recommended to increase productivity and produce other desirable plant characteristics. For best results, trials should be conducted to determine desired rates and timings for optimum responses under local growing conditions.

**Dieffenbachia** sp. - Application to foliage will stimulate flowering for breeding and other purposes. Applications between 250 and 1000 ppm stimulate the production of flowers, increasing the flexibility of breeding programs and frequency of flowers to be used to produce hybridized variants. For best results, trials should be conducted to determine desired rates and timings for optimum responses under local growing conditions.

Spathiphyllum sp. - Application to foliage will stimulate flowering for breeding and other purposes. Applications between 250 and 1000 ppm stimulate the production of flowers increasing the flexibility of production and the ability to sell plants in flower. For best results, trials should be conducted to determine desired rates and timings for optimum responses under local growing conditions.

**Cyclamen sp.-** Application to the foliage will favorably alter the vegetative and reproductive development of the plants. Foliar applications of between 25 and 250 ppm will affect the vegetative and reproductive growth of the plant, thus reducing the days to flowering and enhancing production. For best results, trials should be conducted to determine desired rates and timings for optimum responses under local growing conditions.

**Poinsettia** – Application to poinsettia is used to influence flowering. Foliar applications to plants of between 10 and 50 ppm can be used. For best results, trials should be conducted to determine desired rates and timings for optimum responses under local growing conditions and specific varieties.

**Caladium** sp. – Application will influence flowering. Soaking bulbs in solutions of between 250ppm and 1000ppm will produce a favorable result. For best results, trials should be conducted to determine desired rates and timings for optimum responses under local growing conditions and specific varieties.
