Dear Mr. Smith:

The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act as amended is acceptable provided the following changes are made to the section "CONDITIONS OF SALE AND LIMITED WARRANTY":

1. Change the second sentence of the first paragraph from "Fine Agrochemicals...implied warranty." to "To the extent consistent with applicable law, Fine Agrochemicals Limited makes no other warranties, express or implied, of merchantability or fitness for a particular purpose or otherwise, that extend beyond the statements made on this label."
2. In the second paragraph:
 - a. In the second sentence, delete the phrase "abnormal conditions"
 - b. Change the third sentence from "All such risks shall be assumed by the buyer." to "To the extent consistent with applicable law, all such risks shall be assumed by the buyer."
