DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

This product is intended to be used for controlling pink bollworm (*Pectinophora gossypiella*) in cotton by preventing the male moths from finding and mating with the female moths.

Apply at a rate of 2.8-14.3 grams of formula (2.0 - 10.0 grams of Active Ingredient equivalent) per acre. Note: One packet contains sufficient formula to treat 10 acres at the rate of 5.0 grams of Active Ingredient per acre.

Mix with water and apply final spray solution at a rate which will insure adequate coverage of the crop. May be mixed with approved spreader/stickers and/or vegetable oils. May be applied by conventional aerial or ground spray equipment. This product may be applied alone or tank-mixed in combination with pesticides. If being used with pesticides, add the Decoy PBW Beads to the spray mixture last and use sufficient agitation to ensure uniformity of the spray mixture.

The timing of the initial and subsequent applications should be determined by the level of the pest population at the time of each application.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

STORAGE: Store in a cool, well ventilated area. Protect from ignition sources. Avoid contact with high temperatures, acids, bases. Store sealed to prevent loss of product.

PRODUCT DISPOSAL: This product has been packaged for ease of use and minimization of waste. Unsealed excess product or wastes resulting from the use of this product, may be used on site, or must be disposed of in compliance with applicable Federal, State or Local regulations.

CONTAINER DISPOSAL: Completely empty bag into application equipment. Then dispose of empty bag in a sanitary landfill or by incineration, or, if allowed by State and Local authorities, by burning. If burned, stay out of smoke.
