The following amendment, submitted in connection with registration under section of the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable.

#### **Proposed Amendment**

### Label Comments

- 1. The Keep Out of Reach of Children statement along with the signal word "Danger" the skull and cross bone and the word "Poison" must be placed immediately below the ingredient statement.
- 2. The Precautionary Statements and subheading must be revised to read as follows:

# Precautionary Statement Hazards to Humans and Domestic Animals Danger

"May be fatal if swallowed, inhaled or absorbed through the skin. Corrosive. Causes irreversible eye damage and skin burns. Do not get in eyes, on skin, or breathe dust, vapor or spray mist. Wear goggles and respiratory devise approved by MSHA and OSHA. Wear protective clothing and rubber gloves. Remove contaminated clothing and wash before use."

Note that the Precautionary Statement must be printed in the same type size, except for the subheading, which should be in large bold type size.

3. The subheading "General Precautions and Restrictions" must be placed above the statement to read as follows:

## **General Precautions and Restrictions**

# Provide sufficient general/local exhaust ventilation in pattern/volume to control inhalation exposures below current exposure limits.

4. The statement "Do not contaminate water, food or feed by storage or disposal" must be placed immediately following the storage and disposal statement heading.
