#### **DIRECTIONS FOR USE**

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

#### **APPLICATION DIRECTIONS:**

AntiBlu<sup>®</sup> IP75 may be applied to wood and wood products by immersion or spray methods according to the dilutions provided below. Dilution levels may vary widely and will depend on application methods, wood species, seasonal changes in exposure conditions, length of protection desired, geographical locations, and wood storage and transport conditions.

- For spray applications: Mix one gallon of AntiBlu® IP75 to 15-100 gallons of water.
- For immersion applications: Mix one gallon of AntiBlu® IP75 to 50-300 gallons of water. If lumber is to be treated by dipping, then the treating solution should contact the wood for at least 10 seconds. For block stacked lumber, immersion time must be sufficient to allow penetration of the treating solution to the center of the pack. For best results, green wood should be treated immediately at least within 24 hours after cutting or sawing. Mold and fungus growth begins immediately after cutting so delayed treatment is less effective and requires increased chemical concentration.

Allow treated wood to drain in a contained area before storage, and ensure that freshly treated wood is not allowed to remain unprotected in heavy rains. For actual recommended dilution rates in specific locations/conditions and for a given type of application method (dip or spray) contact an Arch Wood Protection representative for detailed supporting information. Do not apply this product in a way that will contact workers or other persons

#### STORAGE AND DISPOSAL

**PESTICIDE STORAGE:** Do not freeze. Protect from physical damage. Store in a clean, dry, well ventilated area. Keep away from incompatible chemicals and from unguarded flame, sparks, and heat sources. Store in PVC, polypropylene, or polyethylene container. Do not store in Carbon Steel. Do not store above 104°F; Ease of use if stored at 70°F; Do not contaminate water, food or feed by storage or disposal. Open dumping is prohibited. Do not reuse empty container.

Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times.

**PESTICIDE DISPOSAL:** [For containers < 5 gallons] Pesticide wastes are acutely hazardous. Improper disposal of excess pesticide, spray mixture, or rinsate is a violation of Federal Law. If these wastes cannot be disposed of by use according to label instructions contact your State Pesticide or Environmental Control Agency, or the Hazardous Waste representative at the nearest EPA Regional Office for guidance. Triple rinse as follows: Empty remaining contents into application equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Fill the container ¼ full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times.

(CONTAINER DISPOSAL: Nonrefillable container. Do not reuse or refill this container. Offer for recycling if available. Triple rinse container promptly after emptying.
