Based on pyrethrin, a natural insecticide extracted from a rare African flower, Concern[®] quickly kills insects on contact. May be used indoors, outdoors, or in greenhouses throughout the growing season.

Directions for use

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

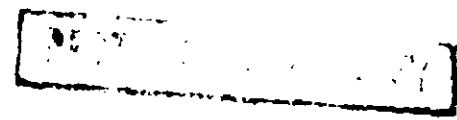
Shake bottle well before each use. Spray when insects first appear. Hold container 12-18" from plant and spray upper and lower leaf surfaces until slightly wet. Wet as many insects with spray as possible. Be sure to penetrate dense foliage. Treatment may be repeated weekly, or as needed to control infestation. Avoid spraying plants in hot midday sun.

For use on Houseplants, Flowers, Trees, and Shrubs, such as: African Violets, Asters, Azaleas, Begonias, Camellias, Carnations, Chrysanthemums, Dahlias, Dieffenbachia, Dogwood, Ferns, Geraniums, Gladioli, Hemlock, Holly, Iris, Ivy, Jade plant, Junipers, Lilacs, Marigolds, Nasturtiums, Orchids, Peperomia, Petunias, Philodendron, Rhododendrons, Roses, Rubber plant, Salvia, Snapdragons, Spruces, Tulips, Wandering Jew, etc.

Storage and Disposal
