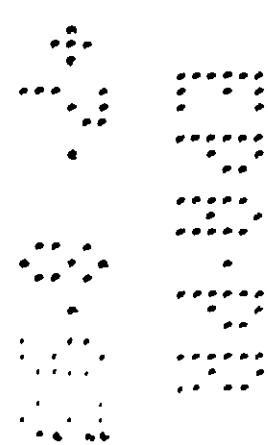

PRECAUTIONARY STATEMENTS

Hazards to Humans & Domestic Animals

WARNING: May be fatal if swallowed. May be absorbed through skin. May be irritating to the eyes and skin. Avoid contact with skin and eyes. When mixing this product for application wear chemical resistant gloves. When apply this product wear a dust mask (particle mask). Wash thoroughly after handling. Do not wear contaminated clothing. Keep away from food, feedstuffs and water supplies. Handle concentrate in a ventilated area. May cause contact sensitization following repeated contact with skin in susceptible individuals. Avoid repeated contact with skin. If sensitization reactions result, consult a physician.

Statement of Practical Treatment

If Swallowed: Call a physician or poison control center immediately. Do not induce vomiting unless no other treatment is available. Drink one or two glasses of water and induce vomiting by touching the back of throat with finger. Do not induce vomiting or give anything by mouth to a convulsing or unconscious person. **If Inhaled:** Remove person to fresh air. Apply artificial respiration if indicated. Contact a physician if warranted. **If on Skin or Clothing:** Remove clothing and wash before reuse. Wash affected skin areas with soap and water. Contact a physician if irritation persists. **If in Eyes:** Immediately flush eyes with plenty of water and call a physician. **NOTE TO PHYSICIAN:** This product is an organophosphate insecticide. If symptoms of cholinesterase inhibition are present Atropine sulphate by injection is antidotal. 2-PAM is also antidotal and may be administered in conjunction with atropine.

Physical or Chemical Hazards

Flammable. Do not use or store near heat or open flame. Do not ship or store with food, feeds, drugs or clothing.

Environmental Hazards

This product is highly toxic to birds, fish, and other wildlife. Birds feeding or drinking on treated areas may be killed. Keep out of lakes, streams ponds, tidal marshes and estuaries. For terrestrial use, do not apply directly to water, to areas where surface water is present or to intertidal areas below the mean high water mark. Do not contaminate water when disposing of equipment washwaters. This pesticide is highly toxic to bees exposed to direct treatment or to residues on blooming plants where they feed. Do not apply this pesticide to drift to blooming plants if bees are visiting the treated area. Do not apply this product to or allow it to drift to food crops or any desirable vegetation at any time.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Do not open pouch except for immediate use.

Use to control flying and crawling insects on exterior surfaces of homes, farm buildings (including dairy barns and milk parlors), warehouses, office buildings, theaters, schools, motels, hotels, factories and outbuildings.

Kills by contact flies, mosquitoes, spiders, ants, ticks, mites, earwigs, fleas, silverfish, chiggers and boxelder bugs.

Mixing Directions: Add one full pouch to one gallon Latex water base paint, oil base paint, or stain, then mix well to insure proper dilution. Do not add more than one ounce to one gallon paint.

STORAGE: Do not store below 10°F (-12°C). Store in a dry locked area inaccessible to children and pets. **DISFOSAL:** Do not reuse empty pouch. Wrap in newspaper and discard in trash.
