Subject: Amendment - Comply with 2000 Diazinon MOA; Delete office buildings, Schools, Hotels, Motels, Warehouses, Theaters, Factories, Farm Buildings (including dairy barns and milk parlors), Barns, and Outbuildings Update First Aid per PR Notice 2001-1; and Update CSF/replacement diazinon source Bug Stuff EPA Registration Number 62366-2 Your submission dated June 26, 2001

The amendment referred to above, submitted in connection with registration under FIFRA section 3(c)(7)(a), is acceptable provided that you:

- Submit and/or cite all data or other material required for registration/reregistration of your product under FIFRA section 3(c)(5) or FIFRA section 4 when the Agency requires all registrants of similar products to submit such data.
- 2. Make the labeling changes listed below before you release the product for shipment bearing the amended labeling:
- a. On the front panel revise the site limitation "For Homes" to read "For exterior use on homes only".
- b. In the Hazards to Humans & Domestic Animals, replace "May be absorbed through skin." with "Harmful if inhaled or absorbed through skin.". Also, revise "Wash thoroughly after handling." to read "Wash thoroughly with soap and water after handling and before smoking or eating.".
- c. In the third sentence of the Note to Physician, add "but only" after "administered".
- d. In the Environmental Hazards, replace the sentence beginning "For terrestrial uses..." with just "Do not apply directly to water." Also, you may delete the last 3 sentence of this section since they deal with the hazards to bees relative to foliar applications to plants.

- e. Under the heading Directions for Use, slightly revise the reformulation prohibition to read ""Reformulation of repackaging of this product is prohibited.".
- f. In the outline box holding the storage and disposal directions, add the heading Storage and Disposal Please be aware that there are minimum type size requirements for this heading.
- 3. Submit three (3) copies of your final printed labeling before you release the product for shipment.
- 4. Comply with all applicable provisions of the 2000 Memorandum of Agreement Regarding Pesticide Products Containing Diazinon (i.e., the Diazinon MOA). In accordance with the Diazinon MOA you have requested the following revisions to the conditions of registration for this diazinon product with outdoor nonagricultural (i.e., home and garden) uses:
- a. You have requested under section 6(f) of FIFRA that this registration be voluntarily canceled on a date not later than December 31, 2004.
- b. You may not manufacture, label, or release for shipment this product after June 30, 2003.
- c. You may not sell or distribute this product after August 31, 2003.
- d. The registration for this product shall expire and be canceled on December 31, 2004.
- e. You will send to every person who directly purchases this product (i.e., to every seller) a notification of Product Recovery Program to be conducted by Syngenta and Makhteshim after December 31, 2004.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

A stamped copy of the label is enclosed for your records.

The Basic Confidential Statement of Formula (CSF) dated June 26, 2001 which identifies a replacement diazinon source Manufacturing Use Product is acceptable and has been added to this product's registration file.
