

- 3. Revise the phrase on page two: "Nordico Bathroom Disinfectant Cloths kill household..." to read "Nordico Bathroom Disinfectant Cloths provide 180 ppm active ingredients to kill household..." Make a similar revision to page three "These towels are pretreated with cleaning and sanitizing chemicals..." to read "These towels are pretreated with cleaning and sanitizing chemicals to provide 180 ppm active ingredients for use in..."
- 4. Revise the phrase on page two: "...to provide effective cleaning, deodorizing, sanitization and disinfection specifically for home, school and food service..." to read "...to provide effective cleaning, deodorizing, sanitization and disinfection specifically for use in homes, schools and food service..."
- 5. Revise the phrase on page two: "...Nordico Bathroom Disinfectant Cloths clean and sanitize vinyl, tile, stainless steel, glass and other hard, non-porous..." to read "...Nordico Bathroom Disinfectant Cloths clean and sanitize vinyl, tile, stainless steel, glass and the following hard, non-porous non-food contact surfaces: food service counters..." deleting the words "other" and "such as".
- 6. Revise the following statement on page two: "Allow cleaned surfaces to remain thoroughly wet for 10 minutes and to air dry." to read (incorporating an underline) "Allow cleaned surfaces to remain thoroughly wet for 10 minutes. Then air dry."
- 7. Make the following revision under the directions "To Clean and Disinfect Toilet Surfaces". "Use a saturated Bathroom Disinfectant Cloth according to the above directions to wipe the lid..."
- 8. Revise the phrase on page three "...they clean and sanitize vinyl, tile, stainless steel, glass and other hard..." to read "they clean and sanitize vinyl, tile, stainless steel, glass and the following hard non-porous surfaces: food service counters, dining table..." deleting the words "other" and "such as". Then add the following statement to the end of the same section: "These towels are not for cleaning or sanitizing food contact surfaces such as utensils, glassware, cookware or food preparation surfaces."

- 9. On page three, change the statement "To clean and sanitize vinyl, tile, stainless steel, chrome, glass and other non-porous hard surfaces." to read "To clean and sanitize the following nonporous hard surfaces: vinyl, tile, stainless steel, chrome, and glass."
- Revise the following phrase on page three "Used towels should be discarded, or rinsed and laundered,..." to read "Used towels should be discarded along with the cleaning and sanitizing sclution, or rinsed and laundered, ... "
- 11. On the first page "First Aid" must be a subheading on a separate line, to be followed on the next line by "If in eyes:..."

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

A stamped copy of the label is enclosed for your records. Submit one (1) copy of the final printed label prior to the release of the product for shipment.

Nordico Bathroom Disinfectant Cloths kill household germs on hard, non-porous, precleaned surfaces to leave your sink, counter-tops and toilet sparkling clean and fresh every time you clean.

Nordico Bathroom Disinfectant Cloths have a phosphate free formulation designed to provide effective cleaning, deodorizing, sanitization and disinfection specifically for home, school and food service environments where housekeeping is of prime importance in controlling the hazards of cross contamination on treated surfaces,

Nordico Bathroom Disinfectant Cloths, when used as directed, are formulated to disinfect the inanimate hard non-porous surfaces of walls, floors, sink tops, outer surfaces of toilet bowls, tables, chairs and telephones.

Nordico Bathroom Disinfectant Cloths deodorize those areas which generally are hard to keep smelling fresh around toilet bowls, garbage storage areas and other hard, non-porous surfaces which develop odors caused by microorganisms.

In addition, Nordico Bathroom Disinfectant Cloths clean and sanitize vinyl, tile, stainless steel, glass and other hard, non-porous non-food contact surfaces such as food service counters, dining table tops and shelves.

### DIRECTIONS FOR USE (FOR HOME OR COMMERCIAL USE:

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Prior to use of this product, remove any gross filth or heavy soil. Do not use on food contact surfaces.

Thoroughly saturate a Bathroom Disinfectant Cloth with water and squeeze three or more times to activate the special cleaning and disinfecting formula that lets you kill household germs every time you clean-up. Allow cleaned surfaces to remain thoroughly wet for 10 minutes and to air dry. To disinfect heavily soiled surfaces, repeat the process with a fresh cloth.

TO CLEAN AND DISINFECT TOILET SURFACES: Use a saturated Bathroom Disinfectant Cloth to wipe the lid, seats, rim sides of bowl and surrounding floor areas and dispose of the used cloth in trash container.

TO CLEAN AND DISINFECT OTHER BATHROOM SURFACES: Use a saturated Bathroom Disinfectant Cloth according to the above directions. Wipe surface to be cleaned thoroughly and dispose of the used cloth in trash container.

#### NON-FOOD CONTACT SURFACE SANITIZING TOWELS

These towels are pretreated with cleaning and sanitizing chemicals, for use in restaurants and other food service establishments on hard, non-food contact surfaces. When activated by water, they clean and sanitize virial, tile, stainless steel, glass and other hard non-porous surfaces such as food service counters, dining table tops, and shelves in customer service areas. Towels should be immersed in 16 ounces of water and squeezed three or more times to activate the special cleaning and sanitizing solution to kill and control bacteria on hard, non-porous, clean or pre-cleaned surfaces. Dampened towels must be stored in cleaning and sanitizing solution between uses.

# DIRECTIONS FOR USE (FOR COMMERCIAL USE):

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Prior to use of this product, remove any gross filth or heavy soil. Do not use on food contact surfaces.

TO CLEAN AND SANTTIZE VINYL, TILE, STAINLESS STEEL, CHROME, GLASS AND OTHER NON-PORQUS HARD SURFACES. Immerse one or more cleaning and sanitizing towels in accordance with the following use dilution chart:

# Towels		Amount of Water	# Towels	Amount of Water
1	; j	l pint	3	1.5 quarts
2		1 quart	4	0.5 gallons

Squeeze towels three or more times to activate the cleaning and sanitizing solution. To clean and sanitize heavily soiled surfaces, visible food particles and other gross debris should be thoroughly removed before using the cleaning and sanitizing towels. Use a wet or dampened towel to clean and sanitize pre-cleaned surfaces. Allow surfaces to air dry. Store towels in the cleaning and sanitizing solution between uses.

The cleaning and smitizing solution should be discarded after 8 hours of use, or sooner if solution becomes dilute or visibly soiled. Used towels should be discarded, or rinsed and laundered thoroughly before use for general cleaning.

To reactivate the system, rinse container with water and repeat the process with a fresh cleaning and sanitizing towel as directed above.
