Dear Mr. Kelly,

The following amendment submitted in connection with registration under FIFRA, as amended, is acceptable with the conditions listed below.

- Addition of marketing claims,
- New directions for wipe pad

Conditions

Revise the label as follows:

- 1. Revise the claim, "Cleans what you can see and what you can't." to read "Cleans what you can see." The phrase, "what you can't" is inappropriate for a general cleaning claim because it is a disinfection claim.
- 2. Revise the following claims by removing the phrase "and disinfects" because the proposed claims are misleading. These claims imply the product is a one step cleaner and disinfectant; however, a preliminary cleaning of heavily soiled areas is required on hard non porous surfaces prior to disinfection.
 - a) Cleans and disinfects [built up] [tough] [grimy] dirt [and grime] [in high-touch areas].
 - b) [The product] [easily] cleans and disinfects dirty, grimy hard non-porous surfaces.
 - c) Use [the product] [wherever you need to clean and disinfect] [tough] [built-up] [dirt and grime] [on hard, non-porous surfaces].
 - d) Cleans [and disinfects] tough, dirt [and grime].

enough active ingredient in one pad to perform as a heavy duty cleaner (white side) on hard nonporous surfaces and as a disinfectant (blue side) on those same surfaces. Therefore, you must revise the directions to state:

General Cleaning: Thoroughly saturate pad with an ounce of water and squeeze three or more times to activate. Using the white side, gently scrub the surface to remove tough dirt and grime. Allow surfaces to air dry. Discard pad when finished.

General Disinfection: For heavily soiled surfaces, a preliminary cleaning is required. Follow General Cleaning direction. Thoroughly saturate pad with an ounce of water and squeeze three or more times to activate the disinfectant. Apply to hard nonporous surfaces. Allow surfaces to remain thoroughly wet for 10 minutes. Then, allow to air dry. Discard pad when finished.

General Comments

A stamped copy of the labeling accepted with conditions is enclosed. Submit three (3) copies of your final printed label before distributing or selling the product bearing the revised labeling.

Dampened towels must be stored in cleaning and sanitizing solution between uses. These towels are not for cleaning or sanitizing food contact surfaces such as utensils, glassware, cookware or food preparation surfaces.


TO CLEAN AND SANITIZE THE FOLLOWING NON-POROUS HARD SURFACES: VINYL, "GLAZED" TILE, STAINLESS STEEL, CHROME AND GLASS. Immerse one of more cleaning and sanitizing towels in accordance with the following use dilution chart:

2	1 quart	4	0.5 gallons

Squeeze towels three or more times to activate the cleaning and sanitizing solution. To clean heavily soiled surfaces, visible and gross debris must be thoroughly removed before using the cleaning and sanitizing towels. Use a wet or dampened towel to clean and sanitize precleaned surfaces. Allow surfaces to air dry. Store towels in the cleaning and sanitizing solution between uses.

Discard the cleaning and sanitizing solution after 8 hours of use, or sooner if solution becomes dilute or visibly soiled. Discard used towels along with the cleaning and sanitizing solution, or rinse and launder thoroughly before use for general cleaning.
