Protects against ticks, mosquitoes, biting flies, fleas, gnats & chiggers.

HOLD UPRIGHT WHEN SPRAYING

DIRECTIONS FOR USE: READ ALL DIRECTIONS BEFORE USING THIS PRODUCT. It is a violation of Federal Law to use the product in a manner inconsistent with its labeling. Do not spray in enclosed areas. Spray on exposed skin. To apply to face and neck, spray palm of hand and spread on face and neck. Apply to socks, shoe tops and openings in outer clothing to repel ticks, fleas and chiggers. Do not apply over cuts, wounds, sunburned or irritated skin. Do not apply to eyes and mouth and do not apply to the hands of young children. Do not spray directly on face. Use just enough repellent to cover exposed skin and/or clothing. Do not use under clothing. Avoid overexposure. Frequent reapplication and saturation is unnecessary for effectiveness. After returning indoors, wash treated skin with soap and water. Wash treated clothing. Use of this product may cause skin reactions in rare cases. If you suspect that you or your child is reacting to this product, wash treated skin and call your local poison control center. If you go to a doctor, take this repellent with you.

Do not use on acetate, spandex, rayon or dyed fabrics. May be used with cotton, denim, wool and nylon. May damage furniture finishes, plastic, leather, watch crystals and painted or varnished surfaces including automobiles.

This product, or any other repellent, will not completely prevent tick bites.
