POINT OF APPLICATION: This product should be added to a point in the system to insure uniform mixing such as the Beater, Hydropulper, o Fan or Broke Storage Pumps.

DOSAGE; Apply 0.44 to 1.5 lbs. (7 to 23 fluid ounces) of product per ton (dry weight) of pulp or paper produced as a stug down. If needed repeat daily, Badly fouled systems should be cleaned before initial treatment.

STORAGE AND DISPOSAL
