Your amendments dated 3/9/92, containing revised Certification with Respect to Citation of Data forms, revised Confidential Statements of Formula (Date 3/7/92) reflecting the removal of sodium bisulfite and ensuring that the upper limit of sulfuric acid does not exceed 0.1 percent, submitted as conditions of registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA) is acceptable provided that you comply with the condition as specified in the summary paragraph below.

Your finished labeling, submitted with your letters of March 17, 1992 for BMP 144(2X) and (3X), is acceptable under FIFRA. Stamped copies are enclosed for your records. With the acceptance of your March 9 and 17, 1992 amendments, you have met and are now in compliance with the conditions of registration as stated in the Agency's April 24, 1990 letter.

With your letters of March 27, 1992, Becker requested minor formulation changes and submitted CSFs (dated March 26, 1992) for the subject products, BMP 144(2X) and (3X). These alternate formulation requests are acceptable provided that you submit by August 17, 1993, the following:

SPECIFIC APPLICATION INSTRUCTIONS

BMP 144 (2X) may be applied in conventional aerial and ground application equipment with sufficient water to provide thorough coverage of the target area. The amount of water needed will be dependent on weather, type of spray equipment and mosquito habitat.

Ground applications should be made in 5-100 gallons per acre in conventional equipment. As low as one gallon per surface area can be used when the target area is open with a light vegetative cover. Aerial applications may be done diluted or undiluted. For undiluted applications, apply 0.20 to 2.0 pts./A of BMP 144 (2X) through fixed wing aircraft or helicopters equipped with conventional boom and nozzles or rotary mist atomizers. For diluted applications, fill the mix tank or aircraft hopper with the appropriate volume of water and agitate before adding BMP 144 (2X). Maintain agitation during loading and spraying.
