Dear Dr. Jachetta,

The revised product labeling referred to above, submitted in connection with the registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable, provided you incorporate the Agency's conditions as enumerated in this letter below and submit two copies of your final printed label prior to releasing the product for shipment.

1) Individual fire ant mound treatments may only be made in connection with public health programs. Therefore the label must specify "For Professional Use Only".

The conditions of paragraph 5 of the June 2000 Memorandum of Agreement apply to this label amendment, specifically this amended label is effective December 1, 2000. Failure to comply with any of the conditions of registration set forth in Paragraph 10 of the MOA shall be

grounds for cancellation of the affected registration(s) under FIFRA section 6(e). Submit two copies of the revised final printed label before you release the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

Applications (To Turf): Apply Dursban 1/2G uniformly to golf course turfgrass at the rate of 5 pounds per 1.000 sq ft, or 4 pounds per 800 sq ft. Consult the table below to determine the amounts of Dursban 1/2G needed for larger-sized areas. Use any hand- or power-operated gravity or rotary type spreader designed for application of granular materials. To help obtain uniform distribution of Dursban 1/2G on the turfgrass, apply one-half of the required amount of product in one direction; then apply the balance at a right angle.

Specific Directions

1. Fire Ant Control (for individual fire ant mounds): Apply Dursban 1/2G at a rate of 4 ounces (8 tablespoons) per active mound. Sprinkle granules gently and evenly over surface of mound and out approximately two feet surrounding the mound. Avoid disturbing ants. For best results, apply when ants are least active in cool weather, 65°F to 80°F, or in early morning or late evening hours. Treat

new mounds as they appear.
