


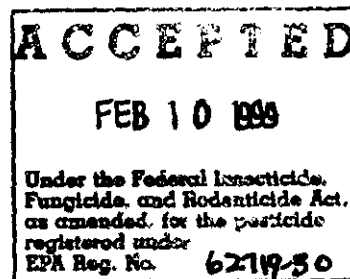

This pesticide is toxic to some plants at very low concentrations.
