- 1. Fill hopper.
- 2. Attach a plastic bag to tube opening.
- 3. Set your planter to the initial settings shown on chart.
- Measure off 1,000 tow feet and drive your planter the pre-measured distance at your desired speed
- 5. Each bag should contain 6 to 8 ounces (wt.) of granules depending on your desired rate.
- If the result is over or under the desired rate adjust the settings and repeat the calibration.
