**If On Skin:** Wash with plenty of soap and water. Get medical attention if irritation persists.

**If Inhaled:** Remove to fresh air if symptoms of cholinesterase inhibition occur and get medical attention immediately.

**Note to Physician:** Chlorpyrifos-methyl is a cholinesterase inhibitor. Treat symptomatically. If exposed, plasma and red blood cell cholinesterase tests may indicate significance of exposure (baseline data are useful). Atropine, only by injection, is the preferable antidote. Oximes such as 2-PAM/protopam may or may not be therapeutic if used early; however, use only in conjunction with atropine. In case of severe acute poisoning, use antidote immediately after establishing an open airway and respiration.

### Environmental Hazards

This pesticide is toxic to fish, birds and other wildlife. Do not discharge effluent containing this product into lakes, streams, ponds, estuaries, oceans or other waters unless in accordance with the requirements of a National Pollutant Discharge Elimination System (NPDES) permit and the permitting authority has been notified in writing prior to discharge.
