Do not get in eyes, on skin or on clothing. Avoid breathing dust. Handle chemical in a ventilated area. Wear protective clothing and rubber gloves when handling. Wash thoroughly with soap and water after handling and before eating or smoking. Remove contaminated clothing and wash before reuse. Keep away from foods, feedstuffs and water supplies.

First Aid

If swallowed: Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give anything by mouth to an unconscious person.

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

If inhaled: Remove to fresh air if symptoms of cholinesterase inhibition occur and get medical attention immediately. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth if possible. Call a poison control center or doctor for further treatment advice.

Have the product container or label with you when calling a poison control center or doctor, or going for treatment.

Note to Physician: Chlorpyrifos-methyl is a cholinesterase inhibitor. Treat symptomatically. If exposed, plasma and red blood cell cholinesterase tests may indicate significance of exposure (baseline data are useful). Atropine, only by injection, is the preferable antidote. Oximes such as 2-PAM/protopam may or may not be therapeutic if used early; however, use only in conjunction with atropine. In case of severe acute poisoning, use antidote immediately after establishing an open airway and respiration.

Environmental Hazards

This pesticide is toxic to fish, birds and other wildlife. Do not discharge effluent containing this product into lakes, streams, ponds, estuaries, oceans or other waters unless in accordance with the requirements of a National Pollutant Discharge Elimination System (NPDES) permit and the permitting authority has been notified in writing prior to discharge. Do not discharge effluent containing this product to sewer systems without previously notifying the local sewage treatment plant authority. Directions for Use

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Only for formulation into an insecticide for the following uses: Direct grain treatment and empty bin treatment.

Additional Labeling Requirements for all End-use Products: All end-use products formulated from this manufacturing use product must contain the following labeling statements:

1. **A statement prohibiting any application method other than direct grain treatment and empty bin treatment. Statements specifying that (1) direct grain treatments must be accomplished by an automated system; (2) empty bin treatments must be made from outside the bin using a downward spray; and (3) instructions for mixing and loading specific to automated and outside bin applications.**
2. **Personal Protective Equipment (PPE):**
Mixers, loaders, applicators and other handlers must wear long-sleeved shirt and long pants, chemical-resistant gloves (such as barrier laminate, butyl rubber, nitrile rubber, or Viton), socks, shoes, and protective eyewear.

In addition, applicators applying to empty grain bins must wear a respiratory protection device (NIOSH-approved dust/mist filtering respirator with MSHA/NIOSH approval number TC-21C or a NIOSH-approved respirator with any N, R, P, or HE filter). See Engineering Controls for additional requirements. Follow manufacturer's instructions for cleaning/maintaining PPE. If no such instructions for washables, use detergent and hot water. Keep and wash PPE separately from other laundry.

Storage and Disposal

Do not contaminate water, food or feed by storage or disposal.

Storage: Store in original container in secured dry storage area. Prevent cross-contamination with other pesticides and fertilizers. Do not store above 100°F. If container is damaged or spill occurs, use product immediately or dispose of product and damaged container as indicated below.

Pesticide Disposal: Wastes resulting from the use of this product may be disposed of on site, if acceptable waste handling facilities are available, or at an approved waste disposal facility.

Metal Drum Disposal: Triple rinse (or equivalent). Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or by other procedures approved by state and local authorities.

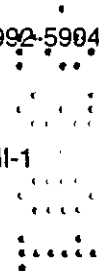
